RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING A RELEASE OF THE PERFORMANCE BOND UPON ACCEPTANCE OF A MAINTENANCE BOND FOR HERITAGE POINT NORTH – SECTION 7B

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township"), has been requested by the developer of Heritage Point North – Section 7B (hereinafter referred to as the "property") for the release of the performance guarantee posted with the Township to guarantee proper installation of site improvements within the property; and

WHEREAS, the Township has received and carefully reviewed a letter of recommendation dated January 27, 2016 from its consulting engineer for the project, John J. Hess, P.E., P.P.; and

WHEREAS, the letter of recommendation is to the effect that all landscaping improvements are acceptable and all site improvements have been properly installed. Therefore the consulting engineer for the Township recommends that the performance guarantee be released contingent upon posting of a two (2) year maintenance bond in the amount of \$13,315.00 which represents fifteen (15%) percent of the original estimated construction cost of \$88,764.00; and

WHEREAS, the Township finds that letter of recommendation from its consulting engineer is appropriate, and in accordance with the Township Land Use Ordinance.
