RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING A CONTRACT FOR THE FURNISHING AND DELIVERY OF ONE (1) COMBINATION SEWER CLEANER TO W.E. TIMMERMAN CO., INC.

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has solicited bids for the furnishing and delivery of one (1) combination sewer cleaner (the "contract"); and

WHEREAS, the bids were solicited by the Township in accordance with the provisions of the New Jersey Local Public Contracts Law, <u>N.J.S.A.</u> 40A:11-1, *et seq.*; and

WHEREAS, the low bid submitted in response to the bid solicitation is from W.E. Timmerman Co., Inc. in the amount of \$378,000.00, which is less than the engineer's estimate for the base bid of \$400,000.00; and

WHEREAS, the Township intends to purchase this equipment with the assistance of a fifty (50%) percent principal forgiveness/grant from NJDEP in the amount of \$189,000.00; and

WHEREAS, the Township believes that it is appropriate, proper and necessary to award this contract inasmuch as it is a needed piece of equipment for the Department of Public Works in order to best protect and provide services to the Township, and will be in compliance with the Township's budgetary constraints.

NOW, THEREFORE, BE IT RESOLVED, this 9th day of February, 2016, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. Conditioned upon receipt of a fifty (50%) principal forgiveness/grant from NJDEP, the Township awards the contract to purchase the combination sewer cleaner
