## RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, RETAINING ECONSULT SOLUTIONS AS ITS EXPERT WITNESS IN PENDING AFFORDABLE HOUSING LITIGATION

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (the "Township") is involved in litigation concerning its affordable housing responsibilities (the "litigation"); and

WHEREAS, the litigation is currently venued in the Superior Court of New Jersey, Law Division, Ocean County, Docket No. OCN-L-1856-15; and

WHEREAS, the Township, through the Municipal Consortium totaling approximately 350 municipalities throughout New Jersey, has previously retained an expert, Econsult Solutions, to prepare an exhaustive expert report detailing the Township's responsibility for meetings its affordable housing obligation ; and

WHEREAS, the litigation is proceeding the trial and the Township needs to retain Econsult Solutions as its expert witness to testify in support of the Township and in support of its expert report; and

WHEREAS, the Township has received a supplemental professional contract for services rendered detailing the expected fees to be charged by Econsult Solutions, which fees will be equally divided between all municipalities in Ocean County who retain its services as an expert witness (currently 13 municipalities in Ocean County are involved in the litigation); and

**WHEREAS**, the proposed Contract has been prepared by the Township Solicitor and the Township finds that it is acceptable as to form and content; and
