5. Committee Reports: Cirulli, Novak, McCabe, Caputo

Al Cirulli – Public works is ready for the impending storm, all parks, beach and dock facilities are secured.

J. Novak – Explained in detail the new Bail Reform and asked that the Township submit a Resolution opposing the new bail reform. Police calls were down from February of 2016 by 53%. Explained what changes will be made to the Police uniform. External Ballistic Gear is riffle resistant from front and back. S. McCabe - Happy to announce that we will be constructing a new Skate Park, already bonded for. Paving of the Municipal Dock should be complete by fall of 2017.

F. Caputo – No report at this time.

6. Mayor's Report

Expressed the great job that the Fire, Police and First Aid did during the fire of February 27th on Bengal Blvd. Happy to report no injuries occurred.

Dave Moore - 70 Rose Hill Road – Spoke about the property known as Barnegat Glenn, 21 acre preserve. Explained that Ocean County is willing to purchase this site for Open Space and asked for Resolution to preserve this site. Also was not happy that the Open Space committee has not met in 3 years. Township must have meetings because it is collecting a percentage of taxes for the Trust fund.

Jerry Harper - 181 Bayshore Drive – Also wanted the Committee to vote yes to have the County purchase Barnegat Glenn for Open Space.

Charlene Costaris - 23 Ridgeway St – Spoke of the increase in taxes from when she moved here in 1974 until now, up approximately 32%.

Jake Taylor – 106 Newark Road – Spoke in length about the history of the Barnegat Glenn property. Want's this committee to 100% support the County's purchase of this property. Also upset about the Open Space Committee not meeting for 3 years, something the Mayor must control.

Frank Pecci – 11 Hemlock Drive – Also wants Committee to agree to have County purchase Barnegat Glenn property.

Bill Dluzniewski – 6 Mystic Cove Terrace – Open Space meetings should be every month.

Daniel Day – 200 Edison Road – Our town has too much debt.

Rafael Adorno – 1 Memorial Drive, Waretown – Talked about the Board of Education's Health benefits and how the Township pays roughly \$10,000 more per person than the Schools. The fact that the PBA still has no contract is fiscally irresponsible of the Town.

Tom Lombarski explained that the amount he was speaking of was before the contribution per person. Bottom line, the Township's cost for health insurance is only about \$700.00 more per person than the Schools health insurance. Matthew Robidoux – 108 Ravenwood Blvd – Liked hearing John Novak on the radio. Asked how much salt we had for the upcoming storm? Talked about the Fire Wise Communities.

Al Cirulli told him 275 tons and also prepared with Brine.

Frank Caputo told him that the next Fire Wise meeting will be May 4th.

Anthony Robidoux – 108 Ravenwood Blvd – Asked if there are laws on Comp Time.

John Novak explained that each town dictates their own Comp time policies.

Michelle Woodruff – 5 Ann Court – Asked about the electronic sign and if it was replacing the sign in front of Town Hall? The answer was no, Resolution 2017-125 is for the Police department. She asked if Brighton can have our current sign when it gets replaced with a new one.

Steve Bauer – 22 Bridgewaters Passage – Asked why we recycle? Also supported having Open Space meetings.

Diane Schlagle – Brighton at Barnegat – Questioned the Transfer Station on 72? Was happy to hear the answer was No.
