5. Committee Reports: Cirulli, Novak, McCabe, Caputo

Al Cirulli- Still working on PBA negotiations. Commended T. Lombarski on having the budget done on time and approved by the state. DPW has informed us that the Dock is open and their two trucks are on order. Deputy Mayor, Caputo and I will be talking to Board of Ed about shared services.

J. Novak- discussed all the police calls and narcotic units accomplishment for the month of March, as well as our detectives solving a burglary incident and recovering some of the property. Overtime has been reduced 73% with 10%

less staff for the month of March. Gave recognition to our CFO, Tom Lombarski for getting the budget done on time and approved by the state.

S. McCabe- Gave CFO Tom Lombarski recognition on the budget and getting it approved along with the police department and their efforts to save money.

F. Caputo- Talked about fire calls, and some brush fires. Barnegat WFSC meets May 11th and is open to the public. Gave our CFO props for getting the budget done and approved on time.

6. Mayor's Report

Al Bille- Deputy Mayor Caputo put together a pamphlet about all the business in Barnegat. The Gravel pit is not a pilot program that is a newspaper misprint. T&K Marina donated the barge for the 4th of July Fireworks. JIF sent 2 awards for Roger Budd and our Water Sewer Department. Buy in Barnegat will begin again on May 1st. Announced our collection rate for taxes last year were 98.2%

Al Cirulli- As part of this program, gave commendation to both sides for what you do. All Barnegat kids will have a field to play on.

Brooke Brigante, 11 Tedesco Way- Soccer parent. Wanted to be on the record that she never started a petition, she was given the petition to pass around.

Al Bille- Explained the merger and how the trustees would be able to vote.

J. Dasti- The two sides need to get together.

S. McCabe- The Township is not looking to make revenue off the kids.

Soccer Parent- Did go to the meeting, and would spend the time listening to an ineffective meeting. There was nothing productive.

S. McCabe- We will not get rid of any club. We need to get along.
