

ORDINANCE 2017-08

ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY CANCELLING CERTAIN FUNDED APPROPRIATION BALANCES HERETOFORE PROVIDED FOR VARIOUS GENERAL CAPITAL PROJECTS TOTALING \$560,000.00 AND REAPPROPRIATING SUCH FUNDED APPROPRIATION BALANCES FOR VARIOUS GENERAL CAPITAL IMPROVEMENTS REAPPROPRIATING THE SUM OF \$560,000.00 TO PAY THE COST THEREOF

BE IT ORDAINED by the Township Committee of Barnegat, County of Ocean, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring) pursuant to the Local Bond Law, Chapter 169 of the Laws of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

SECTION 1. The following funded appropriations remaining as a balance in the bond ordinance heretofore adopted by the Township of Barnegat, County of Ocean, New Jersey ("Township") are hereby cancelled/(re-appropriated to Section 2):

<u>Ordinance #2015-07 (Part 1) – Improvement, expansion and upgrade of the Lower Shore Road Recreation Complex</u>	<u>\$560,000.00</u>

SECTION 2. The aggregate sum of \$560,000.00 is hereby reappropriated from the bond ordinance referred to in Section 1 to the following purposes:

Ordinance #2015-07 (Part 3) - Construction of paved parking lot or area at the Barnegat Municipal Dock

Design and construction of a paved parking lot or area at the Barnegat Municipal Dock, including but not limited to, site preparation and paving work, construction of storm water management system, installation of traffic and event signs, light and security enhancements and landscaping, and including all work and materials necessary therefor or incidental thereto.

Amount of Appropriation -- \$300,000.00

Ordinance #2015-07 (Part 4) – Improvement and enhancement of existing municipal neighborhood playgrounds.

Improvement and enhancement of existing municipal neighborhood playgrounds, including, but not limited to, installation of age appropriate and modern playground equipment and/or skate park, placement of suitable and safe playground and playing surfaces, installation of adequate lighting and security measures, fencing, trash and recycling receptacles, and including all work and materials necessary therefor or incidental thereto.

Amount of Appropriation--\$100,000.00

Ordinance #2015-07 (Part 6) – Acquisition of modern law enforcement computer aided dispatch system for the Barnegat Police Department.

Including the design and installation of a suitable system capable of properly managing and recording the vast operational activities of the Barnegat Township Police Department, and including all else necessary therefor or incidental thereto.


Amount of Appropriation-- \$160,000

SECTION 3. The capital budget or temporary capital budget (as applicable) of the Township is hereby amended to conform with the provisions of this bond ordinance to the extend of any inconsistency therewith, and the resolution promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services, is on file with the clerk and available for inspection.

SECTION 4. This ordinance shall take effect twenty (20) days following the first publication thereof after final passage, as provided by the Local Bond Law.


NOTICE
