RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING A RELEASE OF THE SANITARY SEWER SYSTEM PERFORMANCE GUARANTEE FOR BARNEGAT SENIOR APARTMENTS, BARNEGAT TOWNSHIP, NEW JERSEY

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has received a request for the release of the sanitary sewer system performance guarantee posted on behalf of Barnegat Senior Apartments Barnegat Township, New Jersey (hereinafter referred to as the "property"); and

WHEREAS, the performance guarantees were posted in order to ensure proper installation of all site improvements; and

WHEREAS, in response to the request to release the performance guarantees the Township has received and carefully reviewed a letter dated January 26, 2017 from the Township's consulting engineer; and

WHEREAS, the aforementioned letter confirms that all of the required improvements have been satisfactorily installed and completed, and therefore the Township's consulting engineer has no objection to the release of the performance bond, subject to the following items set forth in the Sanitary sewer Supply System Rules and Regulations:

- a) The applicant must submit the final as-built plans to the Township's consulting engineer in GIS format.
- b) The applicant must make application to the Township for a Certificate of Completion
- c) The applicant must submit all legal documents as are necessary to convey their interest in the facilities to the Township.
- d) The applicant must submit an affidavit that all contractors, subcontractors and materialmen have been paid.

WHEREAS, the Township finds that the recommendations of its consulting engineer is appropriate and proper, and in accordance with the Township Land Use Ordinance.

NOW, THEREFORE, BE IT RESOLVED, this 7th day of March, 2017, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:
