1. The Township hereby reestablishes the position of Planning/Zoning Administrator effective immediately.

2. The Township formally terminates the Shared Services Agreement for these

aforementioned services with the Township of Ocean.

3. The Township acknowledges the assistance and cooperation of the Township of Ocean and thanks them for their decision to enter into the Shared Services Agreement, the
