WHEREAS, a Settlement Agreement has been reached with FSHC which will require affordable housing units to be constructed at no cost to the Township or its taxpayers, but rather by developers who construct homes and commercial properties within the Township; and

WHEREAS, the Settlement Agreement dated April 20, 2017 is on file at the Office of the Township Clerk and can be reviewed by the public during normal business hours; and

WHEREAS, the Township Committee finds that the Settlement Agreement negotiated by the Township Solicitor is acceptable and meets the goals of the Township while allowing the Township to meet its constitutional requirements.
