RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE REMITTANCE OF ONE-HALF OF THE "WATER ESCROW" TO MARK MADISON LLC AS PARTIAL REIMBURSEMENT FOR THE CONSTRUCTION OF WELL NO. 9

WHEREAS, the Township is holding in the Water Escrow account substantial monies from developers who have benefited from the construction of Well No. 9 by Mark Madison, LLC.

NOW THEREFORE BE IT RESOLVED, this 2nd day of May, 2017, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

- The Township authorizes and directs payment in the amount of \$433,818.22 to
 Mark Madison, LLC as partial reimbursement for the construction of Well No. 9.
 Said funds are not Township Taxpayer funds but rather funds originally deposited
 by developers who have benefited from the construction of Well No. 9.
- The Township authorizes and directs the Mayor, Township Clerk, Township
 Administrator and Township CFO to execute any and all necessary documents in
 order to implement the intent of this Resolution.
