

RESOLUTION 2017 - 211

RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE ADVERTISEMENT OF BIDS AND PREPARATION OF SPECIFICATIONS AND BID DOCUMENTS IN CONJUNCTION WITH THE REPAIR OF STORM DRAIN PIPES AT THE TOWNSHIP MUNICIPAL DOCK

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has been advised by its consulting engineer and the Superintendent of the Department of Public Works that storm drain pipes in the bed of the Municipal Dock Parking Lot have deteriorated to an unsafe level; and

WHEREAS, the Township accepts the recommendations of its consulting engineer and Superintendent of the Department of Public Works that the deteriorating storm drain pipes at the Municipal Dock must be repaired; and

NOW, THEREFORE, BE IT RESOLVED, this 2nd day of May, 2017, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township authorizes the Township Consulting Engineer to advertise for bids once the plans and specifications have been prepared.
2. The Township accepts the recommendations of its consulting engineer and Superintendent of the Department of Public Works and therefore authorizes the preparation of designs and specifications, and bid documents, in conjunction with the needed repair of storm drain pipes at the Municipal Dock.
