RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT ON EMERGENCY BASIS TO TOPCOAT PAVING & SEALCOATING, INC. FOR PROVIDING SERVICES TO THE VILLAGE DRIVE BASKETBALL COURT IN ACCORDANCE WITH A PROPOSAL DATED MAY 2, 2017

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has received a recommendation from the Township Administrator as to the necessary emergency repair to the Village Drive Basketball Courts, due to safety and time constraint issues; and

WHEREAS, the Township in response thereto has received a proposal from Topcoat Paving & Sealcoating, Inc. dated May 2, 2017 indicating that the work can be completed on time for a price of no more than \$17,000.00; and

WHEREAS, the Township believes that the recommendation of the Township Administrator is appropriate and in the long term best interests of the Township and its' residents; and

NOW, THEREFORE, BE IT RESOLVED, this 12th day of May, 2017, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township accepts the recommendations of the Township Administrator and awards a Contract on an emergency basis because of safety
