RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, ACCEPTING AS PUBLIC STREETS ALL INTERIOR STREETS WITHIN THE SEA CREST PINES DEVELOPMENT

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has received a request from D.R. Horton, Inc.-New Jersey, developer of Sea Crest Pines (hereinafter referred to as the "developer"); and

**WHEREAS**, Sea Crest Pines is an age-restricted community consisting of 347 proposed lots; and

**WHEREAS**, the Township has received a carefully reviewed a letter dated June 23, 2017 from Todd D. Greene, Esquire, Division Counsel of the developer, whereby the developer has requested a conversion of the drainage basins and road system within the development from private to public ownership; and

**WHEREAS**, the developer, after acceptance of the roads and basins will need to pay to the Township off-site drainage fees of \$2,500.00 per unit in order to provide that the Township will properly maintain the drainage system within the development.
