RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY GRANTING FINAL WATER SYSTEM FACILITIES APPROVAL FOR CARDINALE & BARNEGAT CROSSING ASSOCIATES II, LLC, A/K/A BLOCK 92.111 LOT 24.09, BARNEGAT TOWNSHIP, NEW JERSEY
