RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY GRANTING FINAL SANITARY SEWERAGE FACILITIES APPROVAL FOR THE CARDINALE & BARNEGAT CROSSING ASSOCIATES II, LLC, A/K/A BLOCK 92.111, LOT 24.09, BARNEGAT TOWNSHIP, NEW JERSEY

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has received an application for Final Sanitary Sewer Facilities Approval for property known and designated as Block 92.111, Lot 24.09, Barnegat Township, New Jersey (hereinafter referred to as the “property”); and
