Julia Manhart, 1 Robin Lane - Member of Silver Liners. We senior citizens are a little neglected. The community center has nothing welcoming. There is no pride in the building. The center is set up for the youth. The recreation center needs to be cleaned up along with professional cleaning in the kitchen.

- J. Taylor, 106 Newark Rd.— The recreation was the Senior Center when it was built. Questioned the sand purchased for the bay if a grant is applied for. Resolution 2017-334 and 335, sewer and water, are these normal upgrades?
- J. Hess- This repair and maintenance has nothing to do with new developers. There is concern about the pipes collapsing.

Frank Pecci, 11 Hemlock Dr.- Resolution 2017-319A, increase 1.95% is this what the state allows. Discussed health benefits and recycling grant.

J. Dasti- State cap is 2% on increase. Committee will not receive benefits and the \$8900 for recycling goes back into the budget.

Paula Lawrence, 26 Twilight, Paramount. Discussed the EMS response and gave a synopsis of meeting with the township personnel. She would like to have emergency stationed at the 72 West locations. Stafford Park being a location is better than nothing. Will this be permanent, is this in writing?
