4. Salute to the Flag

5. Committee Reports: Novak, McCabe, Caputo

- J. Novak- Gave police department statistics. Gave thanks to Ward and Whitcraft for running campaign.
- S. McCabe- Gave congratulation to her fellow committee members. Extended happy holidays to all. Addressed a previous meeting regarding beach replenishment.
- F. Caputo-Congratulated John Novak and Al Cirulli. Extended congratulations of the efforts of Mr. Whitcraft and Mr. Ward. Gave the Fire Department statistics. Discussed the Wildfire Safety Council meeting. Complimented the job done on the skate park. Happy holidays to all.

6. Mayor's Report:

As far as the skate park the kids are phenomenal. The new position of the payment box outside has been a success. Happy Thanksgiving to all.

Congratulations to all candidates. Addressed the Rent Leveling Board meeting, and talked about the unnecessary abuse Frank Pecci took.

Read at meeting: Please feel free to speak to the Township Committee during public session. The Barnegat Township Committee appreciates and welcomes public comment, advice and suggestions, especially when it is intended to assist or help the Committee. Comments and discussion will be limited to a five (5) minute period per individual unless requested by the Mayor to continue on a point of clarification. Public Comment at a special meeting of the Township Committee shall be related to the call of that meeting. In accordance with the Committee policy, each participant must be recognized by the Mayor and must preface their comments by a clear announcement of their name, address and group affiliation, if appropriate. Your anticipated courtesy to the members of the public and the committee is appreciated.

7. Motion to Open Public Comment: J. Novak Second: F. Caputo

Keith Germain- Made a statement in regards to the bonding. Gave examples of the needs for the police department.

J. Novak- Gave some information from the CALEA report, in regards to the negative issues in the police headquarters building.

Paul Whitcraft, 11 Wake Road- Commented on Ordinance 2017-27. Concerned about the debt, and is looking for detail. Would like to see if the public can get more detailed information on the ordinances before the meeting. Questioning if anyone on the committee have any conflict of interest with the building of the new town hall.

S. McCabe- Four plus years this has been discussed and it started with renovating the Edwards school.

Al Bille- Details are rough, just because we bond for 14 million doesn't mean we will use it. We would like to have the building on our property, and things we need to find out. This is only a first reading and nothing final tonight. Talked about the building issues, we need to have the money so we can move forward. The Edward School was in the debate, the school board is not looking to do that, and it was looking to cost like \$7 million. There are two readings; it's out to the public now.

J. Novak- Disagrees that conflicts of interest are ok. Contractors that maybe selected that he is affiliated with he will recuse himself from the process. As far as the site, there is not much. The Edwards school would be a great site; he stated he wishes he could get the school board to agree. Talked about the workshop meetings and transparency.

Peg Houle, 10 Rockland St. - Asked about the Town Hall timeline. Will the Recreation center be part of that process?

Al Bille- Yes the recreation center will be part of the process.

Marianne Clemente-, 565 East Bay Ave.-Discussed the workshop meetings and how they were handled years prior to Mr. Novak. Asked about the

Edwards school, why wouldn't we go after it. Questioned a previous bond issued for the public works building. Asked why October meeting wasn't on video.

Novak- I agree, Great question for the school board.

Al Bille- Agreed it's a good question for school board.

McCabe -We were potentially acquiring the Edwards school for a minimal cost. School board changed members and the committee members changed. Both groups pulled it back. After that we were not being invited to contemplate acquiring the building anymore. By definition it's the school boards building.

Jake Taylor 106 Newark Rd. - Discussed the beach replenishment along with the questioning the Bike Path.

F. Pecci, 11 Hemlock Dr. - Talked about the bond estimate and how that number was come up with. Stated he made a call to the state and the sand would be available if the town applied for it. Discussed past things that were to be done to the building along with bonds we already have.

Al Bille- Talked about the Recreation Open Space Inventory ("ROSI") and that we can't do anything with the property, the best bet is that we should try to build on this lot.

- S. McCabe- Explained four years ago she thought this place was going to fall down in a windstorm, today it's that much worse. You reference Mike Ball and Public Works not keeping up with it. Mike Ball and Public Works is chasing, all the repairs, painting and the floor rotting away. We have reached our critical mass. This has been discussed for 20 years, we are out of space, the police department has no lockers, no running water, and we have prisoners walking out because we have no cages to hold them. What will it take, does it need to collapse on itself before you say it's time.
- T. Lombarski- Discussed and explained bonding and budget. Discussed the favorable interest rate, and how it will be paid and structured. We don't pay the school debt, we are just a pass through. Part of the tax rate is the school board
- J. Novak- They got a brand new school that is half empty.

Al Bille- They got a brand new concession stand worth \$600,000.

S. McCabe- They get brand new shiny schools and we have to sit in mold and let this trailer collapse on itself.

Laura Zinger, 14 Beacon Drive.- Coordinator for Settlers Landing Neighborhood Watch, wanted to thank Patrolman Purcell. Asked about Barnegat Blvd. S. being paved, discussed speeding in the development, Recreation Center updates and social media workshops. Is there anything intended to for the Edward School.

J. Novak- Give the streets to Lt. Germain and the police will be sent there. We looked at other facilities to see what we like and don't like. Then we will shop for a building. There is a flow of business that needs to be accommodated.

Al Bille- Discussed how they will take suggestions for the recreation. Nothing intended for the Edwards school to our knowledge.

S. McCabe-Hopes the building finds an alternative function.

Phil Checcia, Windward Drive- Anymore discussions with school board and using our channel? Talked about MacArthur and his visit to Bayville. Discussed the town hall building, it needs to be completed sooner or later. It will cost more if we wait. As far as Edwards for school there is to much asbestos, that building will not accommodate town hall. He suggested other ideas for the Edwards building.

Michelle Woodruff, 5 Ann Ct.- Thanking for the Mayor for looking over the rent leveling meeting, along with Frank Pecci. Stated she is disappointed in the board and there counter proposal was not discussed.

Vince Green, 89 Sandpiper Rd.- Didn't know how bad the Police Department building was. He stated he is in favor of a new building but prefers if it was stand alone. Feels the stand alone is better so the public is not there when they are going through with prisoners.

Al Bille- agrees and appreciates his suggestions.

Matt Robidoux, 108 Ravenwood Blvd.- Who is the alternate to public works? Wanted to ask about the new Public Works yard, will be along with salt yard and plows be stored. Made a complaint about County Dispatch.

Al Bille- No decision on where the building will go.

J. Novak- We will have Mr. Cirulli get back to you on the salt information. In regards to dispatch we are constantly tweaking complaints and issues.

Kim Potter, 175 Gunning River Rd.- Oasis Family Success Center, we offer free services, community and neighborhood gathering. Oasis is a state funding facility.

Diane Schlagle, 32 Kimberly Drive- Asked about Edwards school.

Al Bille- The Edwards school has been an empty building for years. As far as building there are ideas and still in the early stages. We need to watch the budget, so we don't over spend. Our first thought is to build on this piece of property. Like Susan said the Edwards school was one of the options, but it

fell flat, we would have love to take one of the other schools, but that won't happen. Our first thought is to do it on this piece of property.

Bill Cox, 12 Herkimer Ct.-did agree the PD is a mess, agrees that the police station should stand alone. Discussed how Barnegat always talks about keeping the debt down. Could we consider a referendum? Brought up the fact that Police Captain position has been reinstated, and the price tag that comes with it.

Al Bille- We don't know what we are spending, the money is in the bank and we pay nothing until we start to use it.

Keith Germain- Gave a response to Mr. Cox on statistics along with comments from the DCJ. The committee did try to not have a Captain position, but the stats were given to them to justify the reasons why we should be staffed a certain way.

- S. McCabe- Does this show that every shift has a supervisory shift working on the job?
- J. Novak- with our officers working with minimal supervision is a testament to our department.

Chris Linton, 6 Crystal Ct. - He is looking for a response from the CFO about past bonds and debt.

Tom Lombarski- Gave explanation on the current debt and existing bonds.

- J. Novak- Gave a more detailed explanation for Mr. Linton, with ratables and interest rates.
- S. McCabe- Explained the funding and the process. The number is an arbitrary mark in the sand

Al Bille- Gave explanation how we are paying off our debt at phenomenal rate. Stated the condition that the building and parking lot are in.

Angie Sheedy, 339 S. Main St. - Life time member of First Aid Squad, asking about anything being done for the volunteers. Discussed speeding on Rt. 9 and W. Bay Ave, questioned speeding ticket revenue and court fees, asked about the other expenses in the budget.

Al Bille- Explained why it couldn't be done near the election, and will make a note of it to see if there is something that can be done for the volunteers.

- J. Novak- Gave an explanation on what revenue the town receives with tickets and court fees.
- T. Lombarski- You can get a detailed report of the other expenses.

Daniel Day, 200 Edison Rd. - Discussed Committee member health benefits.

Al Bille-January 1st no member of the board gets hospitalization.

George Fedorczyk, 131 Rockrimmon- Discussed the condition of the Police Department. Cautioning the committee about the Edwards school and it might not be practical.

Al Bille- Commented on the Neighborhood watch, and feels it did well.
