ORDINANCE 2018 - 28

ORDINANCE REAPPROPRIATING \$750,000 OF PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSES IN ORDER TO PROVIDE FUNDING FOR A PORTION OF THE COST OF THE CONSTRUCTION OF A NEW PUBLIC WORKS BUILDING FOR THE TOWNSHIP OF BARNEGAT, IN THE COUNTY OF OCEAN, NEW JERSEY

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, IN THE COUNTY OF OCEAN, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39, it is hereby determined that \$750,000 of the proceeds of obligations originally made available pursuant to the Township of Barnegat, in the County of Ocean, New Jersey (the "Township") Bond Ordinance No. 2015-07 finally adopted by the Township Committee of the Township on July 20, 2015 (the "Bond Ordinance"), namely Sections 3(a)(1) and 3(a)(3) of the Bond Ordinance, are no longer necessary for the purposes for which the obligations previously were authorized.

Section 2. The <u>\$750,000</u> described in Section 1 hereof and made available pursuant to N.J.S.A. 40A:2-39, comprised of <u>\$150,000</u> from Section 3(a)(1) of the Bond Ordinance and <u>\$600,000</u> from Section 3(a)(3) of the Bond Ordinance are hereby reappropriated to provide funding for a portion of the cost of the construction of a new Township Public Works Building.

Section 3. The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director of the Division of Local Government Services is on file with the Clerk and is available there for public inspection. Section 4. This ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.
