## **RESOLUTION OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING A REDUCTION OF THE PERFORMANCE GUARANTEE FOR THE SANITARY SEWER SYSTEM IMPROVEMENTS FOR OCEAN ACRES, PHASE 9**
