RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE EXECUTION OF AN AMENDED SCHEDULE "C" AGREEMENT WITH THE COUNTY OF OCEAN FOR 2018

WHEREAS, the Interlocal Service Act, N.J.S.A. 40:8a-1 et seq. authorized the Township of Barnegat to enter into a contract for the provision of certain governmental services with the County of Ocean; and

WHEREAS, N.J.S.A. 40:8 requires such a contract to be authorized by resolution or ordinance; and

WHEREAS, it is the desire of the governing body to authorize the execution of a contract with the County of Ocean and the Mayor of Barnegat Township for the provision of services, materials and equipment as set forth in Schedule "C" attached hereto.

NOW, THEREFORE, BE IT RESOLVED, on January 1, 2018, the governing body of the Township of Barnegat, County of Ocean, State of New Jersey approved the following:

- 1. That the Mayor and Municipal Clerk of the Township of Barnegat are hereby authorized to execute a Schedule "C" agreement with the County of Ocean in accordance with the provisions of the law to include \$13,000.00 for the Road Department, and \$500.00 for Vehicle Services, for a total sum not to exceed \$13,500.00. A copy of the said agreement is attached hereto and made part hereof as Schedule "C".
- 2. This agreement is for the period January 1, 2018 to December 31, 2018.
- 3. That a copy of this agreement referenced herein shall be kept on file and made available in the Municipal Clerk's Office during normal business hours.

WHEREAS, NOW, THEREFORE, BE IT RESOLVED, the governing body of the Township of Barnegat, County of Ocean, State of New Jersey desires to amend the original Schedule "C" agreement with the County of Ocean to address required recycled sweepings, thereby increasing the Road Department portion of the agreement \$32,000 from \$13,000 to \$45,000 approved the following:

1. That the Mayor and Municipal Clerk of the Township of Barnegat are hereby authorized to execute an amended Schedule "C" agreement with the County of Ocean in accordance with the provisions of the law to include \$45,000.00 for the Road Department, and \$500.00 for Vehicle Services, for a total sum not to exceed \$45,500.00. A copy of the said amendatory agreement is attached hereto and made part hereof as Schedule "C".

- 2. This amended agreement is for the period January 1, 2018 to December 31, 2018.
- 3. That a copy of this agreement referenced herein shall be kept on file and made available in the Municipal Clerk's Office during normal business hours.

AMENDATORY AGREEMENT

THIS AMENDATORY AGREEMENT made this _____day of _______,2018, between the County of Ocean, a body politic and corporate in law of the State of New Jersey, hereafter called the party of the first part, and Township of Barnegat, a local governmental unit of the State of New Jersey, hereinafter called the party of the second part.

WHEREAS the governing body of the Township of Barnegat entered into an agreement with the County of Ocean on February 7, 2018 for some type of road maintenance, road overlay, hauling of sweeping and repair of the Local Governmental Unit Roads; and

WHEREAS the said governing body of the Township of Barnegat has now requested that they be permitted to **increase** the amount of the contract.

WITNESSETH that the said parties in consideration of the premises and agreements hereafter contained, do hereby mutually agree as follows:

- 1. The Agreement between County of Ocean and the Township of Barnegat dated February 7, 2018 is hereby amended.
- 2. The governing body of the Township of Barnegat shall pay to the County Treasurer the additional sum of \$32,000.00 for anticipated expenditures for the following:
- 3. The annual total amounts for each category of County services are revised to include the Amendatory Agreement as follows:
