Michelle Woodruff, 5 Ann Court- Is questioning Ordinance 2018-05, what preempted it?

Mayor- Gave explanation on the ordinance.

Al Bille- Getting an attorney to take the position was an issue, we also received negative feedback from an attorney.

AL Cirulli- The Committee wants to give you the support, but unfortunately we have no jurisdiction. As an organization you came together and came together and should be able to handle it.

Diane Grockenberger, 108 Redwood Dr. (Pinewood) Disagrees with the ordinance 2018-05. Discussed the close of the Fire House.

Ray Leszczak, 116 Redwood Dr. (Pinewood)- There is no excuse to remove Chapter 64 even if there is no attorney for the Rent Leveling Board.

J. Novak- Agrees with the point they are making. He would be willing to meet with the residents but decides against due, to any conflict with his position as a lawyer.

Al Cirulli- Agrees the committee should meet with the people, and made a motion to Table the ordinance.

Sean Kean- Gave explanation on how to handle the ordinance if they wanted to table it tonight.

Matt Robidoux, 108 Ravenwood Blvd.- Gave congrats to the Eagles for winning the Super Bowl. He stated that the people should not be yelling at the committee. He feels that John Novak should not be receiving all the negativity. Discussed Township Code 71-19, remove vehicles from the street during snow storm.

Mayor- Explained it's a police matter.

Elaine Taylor, 147 Spruce Circle N.- Discussed the possibility of no one being at the day meeting. Discussed how it is illegal to pile snow on a curb cut. Asked about Mrs. McCabe's contract and salary.

Al Cirulli- The idea was to get people here that can't attend during the night.

Mayor Caputo- Gave explanation and said he would follow up.

Al Cirulli- Gave some explanation on who handled labor issues.

Mayor Caputo, There is a \$10,000 savings by doing things this way.

Al Bille- Gave a breakdown on it will work now and the savings.

M. Lisella- Discussed the base savings and lack of conflict that cost \$43,000 last year.

Bill Cox, 12 Herkimer Court- Brought up the professional contracts and was still looking for clarification on the savings. Questioned Mrs. McCabe contract, and how our former Business Administrator handled it.

M. Lisella- Gave a breakdown on each attorney. Explained how he handles labor issues on a daily basis, but the town needs legal representative.

Phil Checcia, 11 Windward Dr.- Discussed benefits that were given to committee members and the laws. Wants the committee members to payback the money. Questioned Mrs. McCabe position.

Mayor Caputo- All the positions are through a bidding process. The committee makes the decisions and on whom the best candidates will be.

S. Kean- Explained OPMA, and how professional appointments are discussed in closed session.

Robert Martucci 15 Hatteras Way- Discussed contracts and if they can exceed the amount. Discussed Barnegat crime rate and how good it is.

M. Lisella- Gave an explanation about the flat rate contract, and they need to send in a report to the CFO for hours worked.

J. Novak- Mentioned again how people fabricate incidents.

Jake Taylor, 106 Newark Road,- Gave congratulations to Mayor Caputo and Joseph Lopes. Brought up there is no authorization to give benefits to committee members. He is also not in favor of giving Mrs. McCabe the Labor position.

Laura Zinger, 14 Beacon Drive- Gave congratulations to Chief Germain, along with thanks to Barnegat police and neighborhood watch. Discussed the neighborhood watch meetings on Fridays in the courtroom. She also suggested that retired residents help out at the Oasis Family Center. Revisited using social media for township meetings. Encouraged that the senior communities reach out to be a part of the neighborhood watch.

Al. Bille- Asked about any interaction with senior communities, Pinewood Estates and Brighton at Barnegat.

Mayor Caputo- Gave thanks and compliments to Mrs. Zinger for her good work in the community.

Frank Pecci, 11 Hemlock Dr.- Thanks to Al Bille in regards to the remarks about the Rent Leveling Board. Doesn't agree with Resolution 2018-80, feasibility study. Feels his budget questions should be able to be answered. Asked about a company and invoice from TBS.

Tom Lombarski- Asked for a copy of what he is looking for. The document is referring to something in 2012.

Jake- Mentioned its TBS and there is no invoice for this bill. It was all approved by Mr. Breeden.

Mayor Caputo- Stated he will follow up on Mr. Pecci's and Mr. Checchia's concerns and get back to him.

S. Kean- Reiterated that it wouldn't be appropriate if the decisions for RFP's were discussed in public.

George Fedorzyk, 131 Rockrimmon Blvd.- Congratulations to Chief Germain. Asked Mayor Caputo about an email he sent him in reference e to snow plow procedure. He didn't receive any communication back. Asked about the committee meeting times, he thinks the committee should reconsider the times. Recognized Mr. Lopes, and asked him how the committee seat gets filled.

Mayor Caputo- Gave explanation on the open seat and how a municipal vacancy is filled.

Marianne Clemente, 565 E. Bay Ave.- Discussed her concern with the meeting change. Disagrees with Mrs. McCabe's appointment. Wanted to bring up the Presidential issues of offshore drilling, and how she is against it. She has requested to adopt an anti-offshore drilling resolution.

Mayor Caputo- Mention that the committee is considering it and will be discussing it more.

Ann Coles, 105 Freedom Hills Dr.- Wanted to discuss the small companies that are buying up properties and not maintaining them. Asked if there are any ordinances in place.

Mayor Caputo- Explained how we have Code enforcement, and it is the responsibility of the homeowner.

M. Lisella- Explained he gets a monthly reports from code enforcement in regards to tickets and follow up.

Rafael Adorno, 1 Memorial Dr. (Waretown)- Gave congratulations. Questioned Mrs. McCabe's appointment, and her duties. Stated he is happy with Marty's performance, the fact that PBA contract has been settled. Asked about medical benefits being part of a shared service with Waretown. Discussed snow plowing and what the procedures are.

Bill Neyenhouse, 9 Maple Ave.- Wanted to mention as a former committeeman and Mayor, he is not for the change of the meeting times. He feels it's obvious that they want to cut down on the input. Mayor Caputo- Explained that the meeting could be reverted back to the previous times if it's not productive.
