### ORDINANCE 2018 - 1

# AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK IN ACCORDANCE WITH

### N.J.S.A. 40A:4-45.14

WHEREAS, the Local Government Cap Law, N.J.S.A. 40a:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Barnegat Township Committee of the Township of Barnegat in the County of Ocean finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous years final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Barnegat Township Committee hereby determines that a 3.5% increase in the budget for said year, amounting to \$206,637.48 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Barnegat Township Committee hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding year.

NOW, THEREFORE BE IT ORDAINED by the Township Committee of the Township of Barnegat in the County of Ocean, New Jersey, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Township of Barnegat shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased to 3.5% amounting to \$723,231.19 and that the CY 2018 municipal budget for the Township of Barnegat be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon; be filed with said Director within 5 days after such adoption.

**ORDINANCE 2018 - 3** 

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING A CONVEYANCE OF REAL PROPERTY KNOWN AND DESIGNATED AS BLOCK 184 LOT 1 TO R. STONE & COMPANY, INC.

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") has been approached by representatives of a developer, R. Stone & Company, Inc., and Stone Hill at Barnegat, LLC (hereinafter referred to jointly as the "Purchaser"); and

WHEREAS, the Township has been approached to convey to the developer vacant real property owned by the Township known and designated as Block 184 Lot 1, Barnegat Township, New Jersey; and

WHEREAS, the property owned by the Township is surrounded by property owned by the developer, and is currently landlocked and vacant; and

WHEREAS, the parties have agreed to transfer the property to the developer in consideration of \$35,000.00, by quit claim deed; and

WHEREAS, the Township finds that the proposed purchase price is at least equal to the fair market value of this landlocked vacant property; and

NOW THEREFORE BE IT ORDAINED by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

SECTION 1. The Township accepts the proposal submitted by the developer and authorizes a conveyance of the property to the developer for a consideration of \$35,000.00.

SECTION 2. The conveyance will be by quit claim deed.

SECTION 3. The Township finds that this property is landlocked, and not a buildable lot in accordance with the Zoning Ordinances of the Township of Barnegat, and furthermore is completely surrounded by property owned by the developer.

SECTION 4. The Township authorizes and directs the Mayor, the Township Clerk and the Township Administrator to execute any and all necessary documents in order to implement the intent of this Ordinance.

SECTION 5. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.

SECTION 6. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

SECTION 7. This Ordinance shall take effect upon publication in an official newspaper of the Township, as required by and in conformance with law.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

SECTION 1. In accordance with an agreement reached between the Township and the County of Ocean, the Township has transferred all right, title and interest it has in the Cox Museum and Cox House to the County of Ocean.

SECTION 2. In the future the County of Ocean will own the Cox House and the adjoining properties previously owned by the Township, and will provide all of the maintenance, care and day to day activities associated with the Cox House.

SECTION 3. As a result thereof, the Township believes there is no longer any need for Chapter 14 of the Township Code entitled "Cox Museum and Library Management Committee".

SECTION 4. The Township hereby repeals in its entirety Chapter 14 of the Township Code entitled "Cox Museum and Library Management Committee".

SECTION 5. All ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

SECTION 6. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 7. This Ordinance shall take effect upon publication in an official newspaper of the Township, as required by and in conformance with law.

<b>ORDINANCE 2018 - 6</b>		

AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN STATE OF NEW JERSEY CREATING NEW CHAPTER 61 OF THE TOWNSHIP CODE BANNING THE SALE OF PUPPIES AND KITTENS

WHEREAS, a significant number of puppies and kittens sold at pet shops come from large-scale, commercial breeding facilities where the health and welfare of the animals are not adequately provided for ("puppy mills" and "kitten mills," respectively). According to The Humane Society of the United States, it is estimated that 10,000 puppy mills produce more than 2,400,000 puppies a year in the United States and that most pet shop dogs and cats come from puppy mills and kitten mills.

WHEREAS, the documented abuses endemic to puppy and kitten mills include over-breeding; inbreeding; minimal to non-existent veterinary care; lack of adequate and nutritious food, water and shelter; lack of socialization; lack of adequate space; and lack of adequate exercise.

WHEREAS, the inhumane conditions in puppy and kitten mill facilities lead to health and behavioral issues in the animals bred in those facilities, which many consumers are unaware of when purchasing animals from pet shops due to both a lack of education on the issue and misleading tactics of pet shops in some cases. These health and behavioral issues, which may not present themselves until sometime after the purchase of the animals, can impose exorbitant financial and emotional costs on the consumer.

WHEREAS, current Federal, State and County regulations do not properly address the sale of puppy and kitten mill dogs and cats in pet shops.

WHEREAS, prohibiting the retail sale of puppies and kittens is likely to decrease the demand for puppies and kittens bred in puppy and kitten mills, and is likely to increase demand for animals from animal shelters and rescue organizations.

WHEREAS, according to the New Jersey Department of Health 2016 Animal Intake and Disposition Survey, due in large part to pet overpopulation, more than 15,000 dogs and cats are euthanized in New Jersey animal shelters annually. Restricting the retail sale of puppies and kittens to only those that are sourced from animal shelters and rescue organizations will likely reduce pet overpopulation and thus the burden on such agencies and financial costs on local taxpayers; and

WHEREAS, across the country, thousands of independent pet shops as well as large chains operate profitably with a business model focused on the sale of pet services and supplies and not on the sale of dogs and cats. Many of these shops collaborate with local animal shelters and rescue organizations to offer space and support for showcasing adoptable homeless pets on their premises; and

WHEREAS, this Ordinance will not affect a consumer's ability to obtain a dog or cat of his or her choice directly from a breed-specific rescue organization or shelter, or from a hobby breeder where the consumer can see directly the conditions in which the dogs and cats are bred; and

WHEREAS, the Township Committee believes it is in the best interests of this Township to adopt reasonable regulation to reduce costs to the Township and its residents, protect the citizens of the Township who may purchase cats or dogs from a pet shop or other business establishment, help prevent inhumane breeding conditions, promote community awareness of animal welfare and foster a more humane environment in the Township. Section 1. Definitions:

Animal care facility means an animal control center or animal shelter, maintained by or under contract with any state, county or municipality, whose mission and practice is, in whole, or significant part, the rescue and placement of animals in permanent homes.

Cat means a member of a species of domestic cat, Felis catus.

Dog means a member of a species of domestic dog, Canis familiaris.

*Offer for Sale* means to sell offer for sale or adoption, advertise for the sale of, barter, auction, give away or otherwise dispose of a dog or cat.

*Pet shop* means a retail establishment where dogs and cats are sold, exchanged, bartered or offered for sale as pet animals to the general public at retail. Such definition shall not include an animal care facility or animal rescue organization, as defined.

Section 2. Restrictions on the Sale of Animals.

No pet store shall sell, deliver, offer for sale, barter, auction, give away or otherwise transfer or dispose of cats or dogs. Nothing in this section shall prohibit stores from collaborating with animal care facilities or animal rescue organizations to offer space for such entities to showcase adoptable dogs and cats.

Section 3. Severability.

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance which shall continue in full force and effect, and to this end, the provisions of this Ordinance are hereby declared to be severable.

Section 4. Effective Date.

This Ordinance shall take effect upon publication in an official newspaper of the Township, as required by and in conformance with law

AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING THE SALE OF WHATEVER INTEREST IS OWNED BY THE TOWNSHIP IN BLOCK 174.03 LOT 38.02, BARNEGAT TOWNSHIP, TO THE ADJOINING PROPERTY OWNER P & J, LLC, 223 S. MAIN STREET, (COURY'S BODY SHOP) WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (the "Township"), has been contacted by P & J, LLC, owner of Block 174.03 Lot 38.02 Barnegat Township, New Jersey, with regard to the Township's title interest in Block 174.03 Lot 38.02 (the "property"); and

WHEREAS, after review of the title search it appears that the Township may have an equitable interest in a portion of the property which has been titled to P & J, LLC, who has been paying taxes to the Township of Barnegat for the property for a number of years; and

WHEREAS, the adjoining property owner, P & J. LLC, has offered to purchase from the Township any and all rights, title and interest it has in the property, if any, so as to resolve any title issues in the property in favor of the adjoining property owner, P & J, LLC; and

WHEREAS, the Township is permitted pursuant to the provisions of N.J.S.A 40A:12-13(b)(3) to convey to an adjoining property owner for nominal consideration, any and all rights, title and interest it may have in adjoining non-buildable property which has a title issue; and

WHEREAS, the Township Committee believes it appropriate and reasonable to convey, for nominal consideration, any and all rights, title and interest it has in the property to the adjoining property owner, P & J, LLC, who is in title for the property and has been paying appropriate taxes on the property for a number of years, in order to resolve any title issues:

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows: SECTION 1. Pursuant to the provisions of N.J.S.A 40A:12-13(b)(3) the Township hereby authorizes the conveyance of any and all rights, title and interest it has in vacant property known and designated as Block 174.03 Lot 38.02, Barnegat Township, New Jersey.

SECTION 2. The conveyance of the subject property by the Township shall be in favor of P & J, LLC, a New Jersey Corporation, which is the adjoining property owner and is the titled owner to the property. Attached hereto and made a part hereof is a metes and bounds description of the subject conveyance from the Township to P & J, LLC. The consideration to be paid by P & J, LLC to the Township is One Thousand Dollars No/00 (\$1,000.00) which will thereby reimburse the Township in full for any and all costs incurred in this conveyance. SECTION 3. the Township hereby authorizes and directs the Mayor, Township Administrator, Township Clerk and Township Solicitor to execute any and all documents in order to implement the intent of this Ordinance.

SECTION 4. <u>Severability</u>. The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.
