ORDINANCE 2018 - 26

AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 12C ENTITLED, "OFFICERS AND EMPLOYEES" TO AMEND SECTION 12C-7 ENTITLED, "TOWNSHIP COMMITTEE"

BE IT ORDAINED BY the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") as follows:

SECTION 1. Section 12C-7 of the Township Code entitled, "Township Committee" is hereby amended and supplemented to read as follows:

- 2.) No member of the Township Committee or Mayor shall receive payment or compensation (i.e. stipend) for any official Township duties or positions, other than the salary of Mayor or Committee person, to which they are elected or are serving an unexpired term.
- 3.) The Mayor and all Members of the Township Committee shall be ineligible for employment within the Township within two (2) years after serving in the capacity of Mayor or Township Committee person.
- **SECTION 2.** The various parts, sections and clauses of this Ordinance are hereby declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected thereby.
- **SECTION 3.** Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.
- **SECTION 4.** This Ordinance shall take effect upon publication in an official newspaper of the Township, as required by and in conformance with law.

ORDINANCE NO. 2018 – 27

AN ORDINANCE OF THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF BARNEGAT, IN THE COUNTY OF OCEAN, STATE OF NEW JERSEY DELETING CHAPTER 6 OF THE BARNEGAT TOWNSHIP POLICE DEPARTMENT RULES AND REGULATIONS AS CODIFIED UNDER CHAPTER 15 OF THE BARNEGAT TOWNSHIP MUNICIPAL CODE

WHEREAS, the Township of Barnegat, through adoption of Barnegat Municipal Code Chapter 15-9 established a series of municipal regulations which govern the operation of the Barnegat Township Police Department; and,

WHEREAS, the Township of Barnegat Municipal Code Chapter 15-9 refers to a document entitled "Barnegat Township Police Department Rules and Regulations" a copy of which shall be kept on file in the office of the Township Clerk; and,

WHEREAS, the Township of Barnegat desires to delete in its entirety Chapter 6 of the "Barnegat Township Police Department Rules and Regulations" which address Promotional Requirements for the Barnegat Township Police Department; and,

- **NOW, BE IT ORDAINED** by the Township Committee of the Township of Barnegat, in the County of Ocean, in the State of New Jersey, as follows:
- <u>Section 1.</u> Chapter 6: Promotional Requirements of the "Barnegat Township Police Department Rules and Regulations" is deleted in its entirety. This includes Chapter 6:1 through 6:1.14.
- Section 2. All ordinances or parts of ordinances in conflict or inconsistent with any part of this Ordinance are hereby repealed to the extent that they are in such conflict or inconsistent.
 - **Section 3.** This ordinance may be renumbered for codification purposes.
- Section 4. In the event that any section, part or provision of this ordinance shall be held to be unenforceable or invalid by any court, such holding shall not affect the validity of this ordinance as a whole, or any part thereof, other than the part so held unenforceable or invalid.
- <u>Section 5.</u> This ordinance shall take effect upon final passage and publication as provided by law.
