John Novak- Assured we have a 5 year Master Plan shared with the county. We mainly have county roads in this town, because people want to come here there is home growth and adds to all services. He stated that Barnegat is a victim of its own success.

Billy Neyenhouse, 9 Maple Ave.-Questioned Resolution 2019-230, conceptual plan for new building. Wanted to clarify the rate of pay for lifeguard. He feels we need to increase the rate of pay. Gave thanks to the teacher and students.
