RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY SUPPORTING THE NEW JERSEY DEPARTMENT OF TRANSPORTATION SURVEY OF ROUTE 9 BUS STOP LOCATIONS IN THE TOWNSHIP

WHEREAS, The New Jersey Department of Transportation "(NJDOT)" has conducted a survey to inventory all Bus Stops along State and US Routes in New Jersey; and

WHEREAS, this survey was conducted by the engineering firm of IH Engineering, a field review by the NJDOT Bureau of Traffic Engineering and NJ Transit; and

WHEREAS, based upon this survey all currently recommended and existing approved bus stop locations require being approved by a new Traffic Regulation Order (TRO) enabling NJDOT to update regulation files of <u>all</u> existing bus stop locations along Route US 9 in the Township of Barnegat; and

WHEREAS, In order to legally establish these bus stops, the NJDOT is required to promulgate a TRO, and an initial step in the TRO process is to receive a Resolution of Support from the Municipal Governing Body; now

THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey does hereby approve the survey of recommended Bus Stop locations along US Route 9 in the Township of Barnegat as follows:

Bus Stops:

Along Route US 9, northbound, on the easterly side at:

- A. Taylor Lane (near side) (NJ Transit ID# 26274)
 - Beginning at the southerly curb line of Taylor Lane and extending 105 feet southerly therefrom.
- B. <u>Gunning River Road (far side) (NJ Transit ID# 26276)</u>
 Beginning at the prolongation of the northerly curb line of Gunning River Road and extending 100 feet northerly therefrom.
- C. <u>Lower Shore Road (near side) (NJ Transit ID# 26275)</u>
 Beginning at the southerly curb line of Lower Shore Road and extending 105 feet southerly therefrom.
- D. <u>East Bay Avenue (CR 609) (far side) (NJ Transit ID # 26277)</u>
 Beginning at the northerly curb line of East Bay Avenue (CR 609) and extending 120 feet northerly therefrom.
- E. <u>Bay Shore Drive (CR 609) (far side) (NJ Transit ID# 26278)</u>
 Beginning at the northerly curb line of Bay Shore Drive and extending 100 feet northerly therefrom.

Along Route US 9, southbound, on the westerly side at:

- A. Barnegat Boulevard (far side) (NJ Transit ID # 26269)
 - Beginning at the southerly curb line of Barnegat Boulevard and extending 100 feet southerly therefrom.
- B. West Bay Avenue (CR 554) (near side) (NJ Transit ID# 26270)

Beginning at the northerly curb line of the West Bay Avenue (CR 554) and extending 120 feet northerly therefrom.

C. Memorial Boulevard – (near side) (NJ Transit ID# 26272)

Beginning at the northerly curb line of Memorial Boulevard and extending 105 feet northerly therefrom.

D. <u>Gunning River Road – (near side) (NJ Transit ID# 26271)</u>

Beginning at the northerly curb line of Gunning River Road and extending 180 feet northerly therefrom.

E. Georgetown Boulevard – (near side) (NJ Transit ID# 26273)

Beginning at the northerly curb line of Georgetown Boulevard and extending 105 feet northerly therefrom.

Repealer Clause:

The Township of Barnegat concurs that any approved bus stop locations or traffic regulations in conflict with or inconsistent with the provisions of this resolution be rescinded upon approval of the Traffic Regulation Order.
