

**RESOLUTION 2019 – 278**

**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AUTHORIZING UNIFORM SUPPLY AND CLEANING FOR THE PUBLIC WORKS, WATER/SEWER AND CODE ENFORCEMENT PERSONNEL THROUGH THE SOURCEWELL COOPERATIVE PRICING SYSTEM #LOC073**

**WHEREAS**, N.J.S.A. 40A:11-11(5) authorizes contracting units to establish a Cooperative Pricing System and to enter into Cooperative Pricing Agreements for its administration; and

**WHEREAS**, the Township of Barnegat, has offered voluntary participation in a Cooperative Pricing System for the purchase of goods and services; and

**WHEREAS**, on January 1, 2019, the Township of Barnegat’s Governing Body authorized the Township of Barnegat to become a member of the Sourcewell Cooperative formerly NJPA Cooperative Pricing System, membership #31466; and

**WHEREAS**, the Township of Barnegat, pursuant to N.J.S.A. 40A:11-1 et seq., may by resolution and without advertising for bids, purchase any goods or services under the Sourcewell Cooperative Pricing System for any contract entered into on behalf of the Township of Barnegat; and

**WHEREAS**, UniFirst Corporation, 940 River Road, Croydon, PA is an approved Sourcewell Cooperative Pricing System Vendor.

**WHEREAS** that the Chief Financial Officer (“CFO”) does hereby certify the availability of funds with respect to signing a contract with UniFirst, in accordance with the Sourcewell contract #LOC073 to accept the lowest responsible price quote for, uniform cleaning and supply for the Public Works, Water/Sewer and Code Enforcement personnel not to exceed 2019-2020 budgeted amount \$20,000.00;
