Read into the record:

Fred Rubenstein, 4 Hickory Circle-Social media reports that an unnamed "*resident*" objects to the way today's meeting is going forward. To the contrary, it is to the credit of our Township Committee, Administrator, Clerk and others that the instant meeting is convened and the business of Barnegat will be tended to on a timely basis to the benefit of townspeople; to include the anonymous, but vociferous, "*resident*."

Barnegat has many unsung heroes in this time of emergency. From out elected officials, town hall staff to our Police, Public Works, Fire, Recue and others. We see grocery workers, restaurant owners and delivery people, NJ Transit Bus Drivers and more braving the threat of COVID-19 so essential services can continue uninterrupted.

At the time I write this, more than 41,000 New Jerseyites have contracted COVID-19; 1003 of them are dead. Barnegat already has several dozen of our neighbors diagnosed with the Coronavirus.

If any "*resident*" has objection to the prudent methods and procedures put into play for the public good, then stand tall and identify yourself. Identify yourself as I do here...

P. Pipi- Appreciated Fred's comments. This is a full time job and we are here for the residents.

Ellie Rogalski,, 729 W. Bay Ave. This is to advise the Committee that there is development being done and a commercial business being operated on property located at 733 West Bay Ave without any approvals. Commercial trucks from Coastal Garage Doors (the new property owner) appear every weekday morning and remain until the end of the workday. This has been occurring since at least February 28, 2020.

We have reported this repeatedly, as have other neighbors, to Code Enforcement. We are concerned that this business owner is illegally operating a commercial business next door to residential properties in violation of municipal land use ordinances. The Township attorney, Christopher Dasti, Esq., has recently been advised by us that there is no lawfully designated use currently existing on said property. The Planning and Zoning Board Secretary, the Planning Board attorney, the Zoning Board attorney, and the prior Township attorney, Jerry Dasti, Esq. have all been advised of the fact that there is no lawful use of the property when other businesses have attempted to occupy and use the property in the past for unapproved commercial purposes.

We are concerned that during this time of limited government resources, the new property owner, Coastal Garage Doors, is attempting to take advantage of the fact that there is no enforcement mechanism while the Township is closed down due to Covid-19. We have been advised that a Summons has recently been issued. However, since that time, Coastal Garage Doors has continued to operate his business from the property on a daily basis and has continued to make unapproved improvements to the property, including paving an apparent parking area and driveway. As I am sure you are aware, the subject property is located in the Commercial-Village and the Historic District which provides for limited permitted uses. Obviously, the manufacturing of garage doors in not among those. We hope the Township can take the necessary measures to enforce their ordinances to avoid being taken advantage of during this difficult time.

Bill Neyenhouse, 9 Maple Ave.- I have serious concerns regarding Resolution 2020-154 listed on the consent agenda for tonight's meeting. I feel that it's unethical to list this important resolution on the consent agenda as it certainly is not routine. It also does not meet the standards as set forth in the 2013 New Jersey Revised Statues Title 40A- Municipalities and Counties .Section 40A:12-13 - Sales of real property. Selling a 90 year old structure that's significant to the Barnegat Historic District should have required an open discussion with the various groups involved with the district such as the Barnegat Historic Preservation Commission and the Barnegat Historical Society. The committee made a commitment to bring more activities into the downtown and the firehouse/emergency management building could play an important role in doing that. It would be an ideal location for a cultural and art center similar to the Pine Shores Artist Association in Stafford. They are headquartered in a historic building owned by the township. They have a membership 0f over 300 members and offer art classes, art shows and various other activities. I urge the committee to brainstorm with the various groups to find a way to keep the building for a beneficial public use.
