## Committee Reports; Kropf, Bille, Cirulli, Pipi

L. Kropf- Gave a Water/Sewer update, and discussed the water conservation. She mention the total damages due to the lightning strikes. Thanked Tom Lombarski for keeping Barnegat fiscally sound.

Al Bille- Mention the old DPW building will be coming down. Announced municipal tax will not be going up this year. He talked about the some local events that are happening. He mention the issue with opening town hall and how just one of the staff getting sick could impair business inside the building.

Al Cirulli- Discussed his and Mr. Lisella's meeting with the fire department and talked about their needs. The pumper truck will be ordered once they vote on it. He mention the frustration about the Corona Virus. The township has taken precautions to protect the staff and residents. In the result we have not had to deal with and positives results and closing departments down, that other towns have had to deal with. Charles Cunliffe is suing every woman, man and child in Barnegat Township. When you file a lawsuit against our town that is the long-and-short of it. Mr. Cunliffe alleges he has been wrongfully denied the ability to comment at township committee meetings. Nothing could be further from the truth. Like any resident, Mr. Cunliffe had equal opportunity to submit his comments and have them read into and made part of the official record. Mr. Cunliffe would have his neighbors believe that he was denied the ability to interact with township officials. Again, this is false. The email and business telephone numbers of every official, administrator and department are conspicuously posted on our township's website. Why, then, is Charles Cunliffe suing all of us? Why then – at a time when many Barnegat residents are struggling to keep the lights on and put food on the table would Mr. Cunliffe turn a deaf ear and blind eye to the plight of his fellow residents and go into court claiming he has suffered "substantial damages 'What "damages" has Mr. Cunliffe suffered? How has he been harmed? How have his rights been taken away from him? We live in a time of potentially fatal pandemic. All of us are working together to combat this invisible, potentially lethal, enemy that has taken a toll on Barnegat and our nation . We have been unable to enter houses of worship. Restaurants, gyms, beauty salons and more remain shuttered, for the most part. We are living in hell. How many reading this have taken salary cuts? How many have no job to return to? How many are already in arrears on mortgages, car payments, taxes, etc.? But Charles Cunliffe, a man who alleges he was an effective Mayor in nearby Lakewood, thinks this is a perfect time to impose additional financial burdens on those whose votes he seeks. Truth-be-told, a petition for the recall of Charles Cunliffe was circulated by Lakewood residents while he was in public office. A salient portrait if ever one existed. No need to delve into Lakewood. Those familiar with the chaos (to include the murder of a young police officer) know of the social unrest, crumbling infrastructure, sky high taxes and questionable quality of life in that town. That means potentially substantial legal fees that could impact the tax rate by making it go higher. Kicking people when they are down is despicable. And that is precisely what Charles Cunliffe is doing. And it stinks.

Wonder if we could request Township Administrator, Mr. Lisella, who is a good businessman, negotiate a deal for us with a good tree company to trim our trees in front and for some of us in our backyard

- we could pay them monthly or quarterly after they complete a job for us - I notice on estimates that they seem to charge a little less in the winter than in the summer and fall -Over the years of having my trees trimmed, I have encountered a tree company that has expressed he would have charged me more if he had realized my tree was larger than he thought when he first saw it and another tree company expressed that I was lucky to get my tree trimmed for the low amount he charged me - they told me this when working on my trees, after they had given me estimates -One of my neighbors who wants her tree trimmed has a husband in the nursing home for 4 months after a stroke and is experiencing financial difficulty, as me and my other neighbors are experiencing -Would appreciate if Barnegat Township could get us a deal so that the tree company could work on our trees maybe the tree company would be able to complete the job for several of us, if requested by neighbors, it might be more appealing to them if they had 2 or more customers in the same area so they would realize a profit for themselves and not be so unwilling to work on just one person's home. I once again question why this meeting is being held as it's the seventh meeting in a row that violates the Open Public Meetings Act. In light of Mr. Dasti's determination that the meetings comply with the OPM Act I would suggest that he discuss the issue with his colleagues Mr. Brian Rumpf, Esq., zoning board attorney, and Mr. Michael J. McKenna, Esq., planning board attorney. Both of these gentlemen have advised the boards of the requirement to allow public comment during the meeting and they have complied by allowing the public to access the meeting by computer, tablet or smartphone.

The other issue I would like to address is the design of the proposed municipal building. The mayor, committeemen and administrator should be ashamed of the building they have come up with. They have worked on this project for over three years and have never once held a public information meeting to involve the public in the process. This is unheard of in other towns that design a capital project such as this. When Stafford was designing their town hall they went through a long process designing and presenting their rational and plans for a new municipal building. They held a lot of public meetings and went to homeowner, veteran, senior and other groups, It was important to stress the fiscal aspects, and a long range cost savings along with improved services factored with a population growth. We had no opportunity to provide input and as a result have a building that will be an embarrassment for many years.

**C. Dasti-** Planning and zoning is a different entity, they have expertise testimony and cross examination. It's a different animal to that aspect. The committee is taking public comments by email. Mr. Nevenhouse is comparing apples to oranges.

**Al Bille-** Mr. Lisella did a presentation to the planning board which was on Go To Meeting. It is a horrible program. The building will look better than what you see on the rendering. It was out to the public.

**BE IT ORDAINED** by the Township Committee of Barnegat, County of Ocean, State of New Jersey (not less than two-thirds of all members thereof affirmatively concurring) pursuant to the Local Bond Law, Chapter 169 of the Laws of the State of New Jersey, as amended and supplemented ("Local Bond Law"), as follows:

**SECTION I.** It is hereby appropriated from the Capital Improvement Fund the sum of \$525,000 for the purchase of a new Pierce Enforcer Pumper Fire Truck for the Barnegat Fire Dept. including all work and materials necessary therefor or incidental thereto.

**SECTION II**. The capital budget or temporary capital budget, as applicable, of the Township is hereby amended to conform with the provisions of this ordinance to the extent any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the

Division of Local Government Services is on file with the Township Clerk and is available there for public.

**SECTION III.** The purchase described in Section I of this Capital Improvement Ordinance is the fully funded element of the authorized capital project from the Capital Improvement Fund.

**SECTION IV.** This ordinance shall take effect as provided by Law.
