

ORDINANCE NO. 2020- 3

AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN AND STATE OF NEW JERSEY AUTHORIZING AND DIRECTING THE RENAMING OF BOOTHBAY AVENUE TO COVENTRY DRIVE IN THE LIGHTHOUSE VILLAGE AT BARNEGAT DEVELOPMENT

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the “Township”) has been advised that Boothbay Avenue is a continuation of the existing street, Coventry Drive; and

WHEREAS, the Township agrees with the Township Tax Assessor that Boothbay Avenue violates Chapter 55 Section 126.13(F) of the Township Code in that it is a continuation of an existing street, Coventry Drive, and does not have the same name.

WHEREAS, the Township believes that it is necessary and appropriate that Boothbay Avenue in the Lighthouse Village at Barnegat Development be renamed to Coventry Drive.

NOW THEREFORE BE IT ORDAINED by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

SECTION 1. The Township hereby directs that the street named “Boothbay Avenue” in the Lighthouse Village at Barnegat Development be renamed to “Coventry Drive”.

SECTION 2. The Township hereby directs that the address of the vacant lot at 2 Boothbay Avenue, Block 113.05 Lot 1, and owned by Walters Development Co. LLC, shall be changed from “2 Boothbay Avenue” to “158 Fairway Drive”.

SECTION 3. The Township authorizes and directs the Township Tax Assessor, Township Engineer and Township Solicitor to execute any and all necessary documents in order to implement the intent of this ordinance.

SECTION 4. Any ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 6. This Ordinance shall take effect upon second reading publication as required by law.
