## A RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN AND STATE OF NEW JERSEY AWARDING A CONTRACT TO HIGGINS TRUCKING FOR DEMOLITION AT PROPERTY KNOWN AS 69 SCHOONER AVENUE, BARNEGAT, NEW JERSEY, PURSUANT TO ORDER OF THE OCEAN COUNTY CONSTRUCTION BOARD OF APPEALS

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (the "Township") has been involved with Property known as 69 Schooner Avenue, Barnegat, New Jersey and otherwise known as Block 114.25, Lot 9 (the "Property"); and

WHEREAS, the Property has been deemed uninhabitable and a danger to the health, safety, and welfare of the residents of Barnegat Township pursuant to decisions by the Ocean County Construction Board of Appeals as well as the Superior Court of New Jersey; and

WHEREAS, pursuant to the November 21, 2019 Decision of the Ocean County Construction Board of Appeals, the Township is authorized to demolish the unsafe structure located on the Property and file a municipal lien against the Property for all costs incurred by the Township; and

WHEREAS, the Township has solicited a proposal which is under the bid threshold and therefore exempt from public bidding pursuant to N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, the proposal received is from Higgins Trucking Company, said proposal
