RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE RELEASE OF THE DRAINAGE CASH BOND FOR HERITAGE POINT NORTH, SECTION 7A

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey ("the Township"), previously adopted Resolution 2017-390A which required Mignatti Companies to post a cash bond in the amount of \$87,000.00 to insure that all outstanding drainage complaints in Section 7A of the Heritage Point North project have been corrected; and

WHEREAS, to date, \$45,000.00 remains on the cash bond as all other matters have previously been addressed; and

WHEREAS, the Township Engineer has completed the inspections and has recommended the full release of the cash bond remaining, \$45,000.00, pursuant to the Township Engineer's November 26, 2019 correspondence and the Township Engineer's January 23, 2020 correspondence, both of which are attached hereto and made a part hereof; and

WHEREAS, the Township accepts the recommendation of its professional staff; and WHEREAS, the Mignatti Companies have further advised that the entire cash portion remaining (\$45,000.00) is to be transferred into a separate escrow account for the Township to be utilized for the posting of a cash bond to finalize the landscape issues for Section 6A, 6B, 7A and 7B of Heritage Point North, pursuant to Resolution Nos.: 2020-70, 2020-71, 2020-72, and 2020-73.

NOW, THEREFORE, BE IT RESOLVED this 4th day of February 2020 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey as follows:
