Linda Kropf – Went over water/sewer report. Still working on meter switch out project. Routine cleaning ongoing. Thanked Barnegat Township employees for their hard work during the pandemic. Linda Bernal will be retiring in June and wishes her well.

Pat Pipi – Spoke about the code enforcement report. Congratulated the Mayor and Marty Lisella for warning our residents about the negative comments on Facebook, which the comments has slowed down.

Joe Marte – Reviewed the police report for the month. We had 1700 calls for service, 8 arrests and \$1600 in heroin and other drugs. The transition of the Stafford dispatcher service has gone very well. Great job! Honored 2 police officers who are veterans, Joseph Peragine and Stephen Russoniello. Read a poem that he wrote for our veterans in honor of Memorial Day.

Mayor's Report – Albert Bille – Former employee Nancy Maloney passed 4/20/21 she was a Police Clerk from 1975-2011 – 36 years. Former employee Dona Demola passed on 4/16/21 she was a Clerk Typist from 1988-2018 – 30 years. In 2018 hired Chief Keith Germain. We have the lowest crime rate.

"Safewise" is a home safety website and Barnegat is one of the safest town in the county. Thanked our Chief and Officers for a job well done! Please don't use Facebook for your questions, please call Town Hall. There are always Township employees here for any concerns. Verizon was sent a letter requesting service in Barnegat. We had a Barnegat winner at our car show. 83 cars at our drive in movie. Project playground still waiting on parts. Our first concert will be held on May 29th. Happy Mother's Day! ORDINANCE NO. 2021- 8

**AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN AND STATE OF NEW JERSEY
AMENDING AND SUPPLEMENTING CHAPTER 66 OF
THE TOWNSHIP CODE ENTITLED "STREET AND
SIDEWALKS" AND SPECIFICALLY §26 THEREOF
ENTITLED "PERMITS REQUIRED; FEE".**

NOW THEREFORE BE IT ORDAINED by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey that Chapter 66 of the Township Code entitled "Streets and Sidewalks" and specifically §26 thereof entitled "Permits Required; Fee" is hereby amended as follows:

SECTION 1. That Chapter 66 of the Township Code entitled "Streets and Sidewalks", specifically §66-26 entitled "Permits Required; Fee" is hereby amended to read as follows:

§66-26 Permits Required; Fee.

- A. [Unchanged].
- B. The following schedule of fees is hereby fixed, determined, and established as being the fees to be paid to the municipality for the issuance of permits in connection with the servicing of permits and supervision and inspection of openings and drainages to proper restoration.

Openings up to 50 square feet in length \$50.00.

Openings over 50 square feet but less than 500 square feet
\$100.00.

Openings over 500 square feet but less than 1,500 square feet
\$150.00.

Openings over 1,500 square feet \$200.00.

Such fees shall accompany the application when filed with the Construction Official or other designated agent.

- C. No person shall open or dig a trench in any public road, street or highway in this municipality without having given the municipality a cash or surety company bond to guarantee that the opening or trench made by the permittee will be properly closed and the road, street or highway over same reconstructed so that it will remain in good condition for at least two (2) years after the closing by the permittee. The minimum amount of each bond shall be two thousand five hundred dollars (\$2,500.00). If the opening or trench is over one hundred (100) square feet in length, the amount shall be twenty dollars (\$20.00) per square foot of the length thereof. A utility company and developer shall, in lieu of given a

separate maintenance bond on each project, annually, once in January in each year, give a cash bond or surety company bond in the amount of twenty thousand dollars (\$20,000.00); provided that when the total lineal footage of openings or trenches made by such utility company reaches two thousand five hundred (2,500) square feet, such utility company shall give either an additional bond or deposit cash security in the amount of twenty dollars (\$20.00) per square foot of length of additional opening or trenches it desires to make in the calendar year.

- D. All cash or surety bonds shall remain on deposit with the Township for a period of two (2) years following the satisfactory completion of all roadway reconstruction work. Upon the expiration of the two (2) year period, the street or trench opening shall be inspected by the Township Engineer. If found to be acceptable condition, then the bond will be released. If the reconstruction work is found to be unsatisfactory, then all required repairs must be completed to the satisfaction of the Township Engineer before the bond will be released.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.

ORDINANCE NO. 2021- 9

AN ORDINANCE OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN AND STATE OF
NEW JERSEY AMENDING AND SUPPLEMENTING
CHAPTER 55 OF THE TOWNSHIP CODE
ENTITLED "LAND USE" AND SPECIFICALLY
SECTION 55-5 ENTITLED "GENERAL
PROVISIONS" AND SPECIFICALLY SECTION F
THEREOF ENTITLED "MARIJUANA, CANNABIS
AND/OR PARAPHERNALIA" TO PROHIBIT THE
OPERATION OF ANY CLASS OF CANNABIS
BUSINESSES WITHIN THE TOWNSHIP OF
BARNEGAT

WHEREAS, in 2020 the voters of New Jersey approved Public Question No. 1,
which amended the New Jersey Constitution to allow for the legalization of a controlled
form of marijuana called "cannabis" for adults at least 21 years of age; and

WHEREAS, on February 22, 2021, Governor Philip Murphy signed into law
P.L. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement
Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the
recreational use of marijuana by adults 21 years of age or older, and establishes a
comprehensive regulatory and licensing scheme for commercial recreational (adult use)
cannabis operations, use and possession; and

WHEREAS, the Act establishes six marketplace classes of licensed businesses,
including:

- Class 1 Cannabis Cultivator license, for facilities involved in
growing and cultivating cannabis;
- Class 2 Cannabis Manufacturer license, for facilities
involved in the manufacturing, preparation, and packaging
of cannabis items;
- Class 3 Cannabis Wholesaler license, for facilities involved
in obtaining and selling cannabis items for later resale by
other licensees;

- Class 4 Cannabis Distributer license, for businesses involved in transporting cannabis plants in bulk from one licensed cultivator to another licensed cultivator, or cannabis items in bulk from any type of licensed cannabis business to another;
- Class 5 Cannabis Retailer license for locations at which cannabis items and related supplies are sold to consumers; and
- Class 6 Cannabis Delivery license, for businesses providing courier services for consumer purchases that are fulfilled by a licensed cannabis retailer in order to make deliveries of the purchases items to a consumer, and which service would include the ability of a consumer to make a purchase directly through the cannabis delivery service which would be presented by the delivery service for fulfillment by a retailer and then delivered to a consumer.

WHEREAS, section 31a of the Act authorizes municipalities by ordinance to adopt regulations governing the number of cannabis establishments (defined in section 3 of the Act as “a cannabis cultivator, a cannabis manufacturer, a cannabis wholesaler, or a cannabis retailer”), cannabis distributors or cannabis delivery services allowed to operate within their boundaries, as well as the location manner and times operation of such establishments, distributors or delivery services, and establishing civil penalties for the violation of any such regulations; and

WHEREAS, Section 31b of the Act authorizes municipalities by ordinance to prohibit the operation of any one or more classes of cannabis establishments, distributors, or delivery services anywhere in the municipality; and

WHEREAS, Section 31b of the Act also stipulates, however, that any municipal regulation or prohibition must be adopted within 180 days of the effective date of the Act (by August 22, 2021); and

WHEREAS, Section 31b of the Act, the failure to do so shall mean that for a period of five years thereafter, the growing, cultivating, manufacturing, selling and reselling of cannabis and cannabis items shall be permitted uses in all industrial zones,

and the retail selling of cannabis items to consumers shall be a conditional use in all commercial and retail zones; and

WHEREAS, at the conclusion of the initial and any subsequent five-year period following a failure to enact local regulations or prohibitions, the municipality shall again have 180 days to adopt an ordinance regulating or prohibiting cannabis businesses, but any such ordinance would be prospective only and would not apply to any cannabis business already operating within the municipality; and

WHEREAS, the Township Committee of the Township of Barnegat has determined that, due to present uncertainties regarding the potential future impacts that allowing one or more classes of cannabis business might have on New Jersey municipalities in general, and on the Township of Barnegat in particular, it is at this time necessary and appropriate, and in the best interest of the health, safety and welfare of the Township of Barnegat's residents and members of the public who visit, travel, or conduct business in the Township of Barnegat to amend the Township of Barnegat's zoning regulations to prohibit all manner of marijuana-related land use and development within the geographic boundaries of the Township of Barnegat; and

WHEREAS, officials from two prominent non-profit organizations that have been established for the purpose of advising New Jersey municipalities on legal matters such as have been presented by the Act (those organizations being the New Jersey State League of Municipalities and the New Jersey Institute of Local Government Attorneys) have strongly urged that, due to the complexity and novelty of the Act, the many areas of municipal law that are or may be implicated in decisions as to whether or to what extent cannabis or medical cannabis should be permitted for land use purposes or otherwise regulated in any particular municipality, and the relatively short duration in which the Act would allow such decisions to be made before imposing an automatic

authorization of such uses in specified zoning districts subject to unspecified conditions, the most prudent course of action for all municipalities, whether or not generally in favor of cannabis or medical cannabis land development and uses, would be to prohibit all such uses within the Act's 180-day period in order to ensure sufficient time to carefully review all aspects of the Act and its impacts;

NOW THEREFORE, BE IT ORDAINED, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

SECTION 1. Chapter 55 of the Land Use Code entitled "Land Use" and specifically subsection 55-5 thereof entitled "General Provisions", and subsection F thereof entitled "Marijuana and/or Paraphernalia" is hereby amended to read as follows:

§55-5 General Provisions.

F. Marijuana, Cannabis and/or Paraphernalia.

Pursuant to section 31b of the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act, P.L. 2021, c. 16, all cannabis establishments, cannabis distributors or cannabis delivery services are hereby prohibited from operating anywhere in the Township of Barnegat, except for the delivery of cannabis items and related supplies by a delivery service.

The following uses or activities are hereby prohibited anywhere within the Township of Barnegat:

All classes of cannabis establishments or cannabis distributors or cannabis delivery services as said terms are defined in section 3 of P.L. 2021, c. 16, but not the delivery of cannabis items and related supplies by a delivery service.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of

competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
