Call to Order the August 3, 2021 Township Committee Meeting:

Committee Reports; Linda Kropf, Pat Pipi, Joseph Marte, Alfonso Cirulli

Linda Kropf – Gave the water report. Spoke about the meter switch out program, in hope to be using new system in September. CME working on a hydrologic study for our water system.

Pat Pipi – Spoke about the code enforcer report. Complimented Scott Docherty and public works on a great job on the aftermath of the tornado. Talked about others political standpoints.

Joseph Marte – Went over the police report. Police department answered 1,485 calls in July. Overtime was the lowest this year in July. Honored Chief Germain. Read residents letter about Ptl. Latini, praised her for helping them and how she went above and beyond. Memorial service on Sept. 11, 2021 held at Barnegat High School from 8:00 am – 9:00 am.

Alfonso Cirulli – New pumper truck arriving within the next 2 weeks. No bonding! Talked about Comcast including the high school in channel 22 – Bengal Buzz, concerts, game of the week, ROTC. Spoke about Starve Poverty.

<u>Mayor's Report – Spoke</u> about how there was no bonding for the fire truck, public works building or the new town hall. Celebrated WWII Veteran, Walter Radcliff's 100th birthday. Attended the swearing in of Eagle Scout, Christian Babbage. Bids soon will be opened for W. Bay Ave between Rt. 9 and Barnegat Blvd. Thanked everyone involved for the great clean up at beach after tornado. Welcomed Women Health Care Group and Barnegat Bay Ice Cream to town. Taxes will have the smallest increase in 9 years, \$2.73 a month.

<u>Administrator's Corner:</u> Tax bills were brought to a facility in West Jersey on 7/29/21 and should be arriving in mail soon.

Charlie Cunliffe: 135 Rockrimmon Blvd. – Thanked public works, police and everyone involved for cleaning Bay Beach after the tornado on 7/29/21. Spoke about virtual meeting if we have another shut down and to consider looking into channel 22. Talked about how upset he was with the July meeting.

Dave Kritsik: 186 Chestnut Dr. – Upset with the meetings being held and mentioned to stop the nonsense. The public needs to take responsibility on these issues. He appreciates and thanked for helping the Jeff's Camp get started.

Victor Passiatore: 7 Liberty Court – Had asked committee for help with an ongoing issue on Liberty Court that's been going on with a resident running a transit company out of home. Have been asking for help since 2018. Would appreciate any help. Mr. Dasti mentioned that there is a pending court matter.

Susan Romei: 222 Rahway Rd. – Formally requesting that Rahway Road to be paved. It has not been paved for 50 years. There are 45 homes on our road and contributes over \$400,000 in taxes every year. Gave petition and pictures to clerk for record. Also statements from the residents.

Marianne Clemente: 565 E. Bay Ave. – Very embarrassed by the July meeting. The Mayor needs to take control of when people speaks the way they do. Mentioned that it was staged when Rubenstein spoke. We have the right to free speech. Hoping that things will change.

Scott Sobel: 12 Montauk Place – Spoken previously about drainage issue in front of property. DPW did come out and patched it up. Asked if engineer can look into it. Showed pictures of the problem.

Steve D'Agostino: 25 Nautilus Dr. – Resident in town for over 10 years. Happy with the town and likes everyone in town. He would like some help with a tax situation before it goes to court. Mr. Dasti said that they will look into it for him.

Frank Ernest: 402 N. Main St. (Garden Center) – Never comes to meetings. Upset to see what went on at last meeting. Asked about when the gas lines will be installed on Rt. 9. Kurt Otto will let him know.

John Gennarelli: 102 Pine Oak Blvd. – Thanked Mr. Cirulli for his help with IT. Looking for CDL bus drivers, starting at \$22.00 an hour. Upset with July meeting. Don't want to hear what happened in the past. Like to know the good news not the negative. If you see something, say something.

Bill Neyenhouse: 9 Maple Ave. - Not sure how to begin. Very upset with July meeting. Mayor needs to step down if he can't run a meeting. Stated NJ State Police crime records. Chief Keith Germain - Stated that the crime rate was listed in "Safe Wise" magazine. Crime was 3 ½ times higher in the 90's then now.
