

**RESOLUTION NO. 2021 – 117**

**RESOLUTION OF THE TOWNSHIP OF  
BARNEGAT, COUNTY OF OCEAN, STATE OF  
NEW JERSEY, RESCINDING RESOLUTION 2021-  
89, AND REJECTING ALL BIDS, AND  
AUTHORIZING THE REBID FOR THE OWNER'S  
REPRESENTATIVE FOR THE MUNICIPAL  
BUILDING PROJECT**

**WHEREAS**, the Township of Barnegat, County of Ocean, State of New Jersey (the "Township") previously solicited bids for the Owner's Representative for the New Barnegat Township Municipal Building Project (the "Project"); and

**WHEREAS**, the bid was awarded pursuant to Resolution 2021-89; and

**WHEREAS**, subsequent thereto, the Township has determined that there were irregularities with the bid and request for the solicitation of bids which requires clarification and revisions to the bid solicitation and re-advertisement; and

**WHEREAS**, the Qualified Purchasing Agent will revise the bid specifications and schedule the re-advertisement of same.

**NOW, THEREFORE, BE IT RESOLVED** on this 2nd day of March 2021 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township hereby rescinds Resolution 2021-89 and rejects all bids that were received for the Owner's Representative for the New Municipal Building Project.
2. The Township's Qualified Purchasing Agent will revise the bid specifications and re-advertise the bid.
3. The Mayor, Township Clerk, and Township Administrator and Township Qualified Purchasing Agent are hereby authorized to execute any and all documents to implement the intent of this resolution.
