**RESOLUTION OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AUTHORIZING EXECUTION OF
CHANGE ORDER AND FINAL PAYMENT FOR
PINE OAK BOULEVARD IMPROVEMENT
PROJECT—PHASE I**

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) previously authorized the Pine Oak Boulevard Improvement Project—Phase I (the “Project”) to Earle Asphalt Company; and

WHEREAS, the Township has received and reviewed an application for final payment for the project; and

WHEREAS, the final payment voucher and change order have been reviewed by the Township’s professional staff and found to be appropriate; and

WHEREAS, the change order results in a total reduction in the project in the amount of \$11,810.63; and

WHEREAS, the original contract in the amount of \$268,013.13 based upon the change order the final payment by the Township would be a total of \$256,202.50; and

WHEREAS, the final payment application and change order is attached hereto and made a part hereof; and

WHEREAS, Township finds its necessary and appropriate to approve the change order and authorize the final payment in the amount of \$28,887.67 on the project.

NOW, THEREFORE, BE IT RESOLVED on this 6th day of April 2021 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

The Township hereby authorizes the change order and final payment for the Pine Oak Boulevard Improvement Project Phase I which authorizes a change order resulting in a deduction of \$11,810.63 and approving a final payment in the amount of \$28,887.67. As a result, the total adjusted payment for the Project is \$256,202.50, which is \$11,810.63 less than the total original contract amount of \$268,013.13.
