**RESOLUTION OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN, STATE OF
NEW JERSEY, AUTHORIZING CHANGE ORDER
NUMBER 1 AND CHANGE ORDER NUMBER 2
FOR THE NEW MUNICIPAL BUILDING**

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) awarded a bid for the new Barnegat Township Municipal Building and Police Department Project (the “Project”) to Frankoski Construction Company Inc.; and

WHEREAS, the Township has received General Change Order Number 1 and General Change Order Number 2 which are attached hereto; and

WHEREAS, the change orders have been reviewed by the Township’s architect and found to be acceptable as to form and content and has recommended approval by the Township; and

WHEREAS, Change Order Number 1 is a reduction and reimbursement to the Township in the amount of \$13,200.00; and

WHEREAS, Change Order Number 2 is a Change Order with regard to an increase of \$12,579.00; and

WHEREAS, the Township accepts the recommendations of its architect for approval of Change Order Number 1 and Change Order Number 2.

NOW, THEREFORE, BE IT RESOLVED on this 6th day of April 2021 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township authorizes the execution and approval of Change Order Number 1, attached hereto, resulting in a reduction and reimbursement to the Township in the amount of \$13,200.00.
