WHEREAS, qualifications have been received and reviewed by the Township.

- **NOW, THEREFORE, BE IT RESOLVED** on this 4th day of May 2021 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:
- 1. The Township appoints Legacy Construction Management, Inc., 5021 Industrial Road, Wall, NJ 07727 as its Owner's Representative to the New Township Municipal Building Project and specifically, Steve Post shall serve as the On-Site Project Manager and Owners Representative. Pursuant to the contract and bid specifications for the Project, this appointment is at no cost to the Township and payment for all services to Legacy Construction Management, Inc. shall be paid directly by the General Contractor of the Project, Frankoski, Construction Co., Inc. This contract is for the award of a professional service and extraordinary unspecified services pursuant to the New Jersey Local Public Contracts Law N.J.S.A. 40A:11-1 et seq.
