

**RESOLUTION NO. 2021 – 95**

**RESOLUTION OF THE TOWNSHIP OF  
BARNEGAT, COUNTY OF OCEAN, STATE OF  
NEW JERSEY, DENYING REQUEST FOR  
RELEASE OF PERFORMANCE GUARANTEES  
FOR SANITARY SYSTEMS FACILITIES FOR  
WHISPERING HILLS PHASE 3**

**WHEREAS**, the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has received a request from the developer Walters Development Company, for bond releases for sanitary system facilities for the project known as Whispering Hills Phase 3 (the “Project”); and

**WHEREAS**, the Township Engineer has performed a site inspection of the sanitary sewer system facilities improvements; and

**WHEREAS**, the Township Engineer has confirmed that all the present improvements have been installed in a satisfactory manner; and

**WHEREAS**, pursuant to the October 4, 2017 review memorandum by the Township Engineer, the Township Engineer previously noted substantial completion of the improvements and recommended at that time, the maximum reduction to 30% of the original performance guarantee amount; and

**WHEREAS**, the Township Engineer issued a review memorandum dated January 8, 2021 which is attached hereto and made a part hereof confirming that no further reductions can be granted at this time; and

**WHEREAS**, the Township accepts the recommendations of its professional staff.

**NOW, THEREFORE, BE IT RESOLVED** on this 2<sup>nd</sup> day of February 2021 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:
