

ORDINANCE NO. 2021- 07

**AN ORDINANCE OF THE TOWNSHIP OF BARNEGAT,
COUNTY OF OCEAN AND STATE OF NEW JERSEY
AMENDING AND SUPPLEMENTING CHAPTER 48-9 OF
THE TOWNSHIP CODE ENTITLED “RECEPTACLE
REQUIREMENTS”.**

NOW THEREFORE BE IT ORDAINED by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey that Chapter 48-9 of the Township Code entitled “Receptacle Requirements” is hereby amended and supplemented to include new Subsection B.

SECTION 1. That Chapter 48-9 of the Township Code entitled “Receptacle Requirements”, is hereby amended to add Subsection B which shall read as follows:

§48-9 Receptacle Requirements.

- B. On days of inclement weather, which shall include high winds, residents may place solid waste at the curb in secured black trash bags rather than the thirty-two (32) gallon trash receptacles. All of the other provisions set forth in Subsection A with regard to items that shall not be placed in the trash receptacle shall also apply to solid waste in black trash bags.

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.
