Al Bille: Drive-in movies will now be held at the high school. Family Bingo will be on June 2nd at 6:30. Mentioned that Stafford taxes went up \$58 per household for the year, Brick went up \$48, Lacey and Waretown went through the roof. For Barnegat, we only went up \$22.29. First concert will be on May 28th. Public Works will be painting bathrooms at the docks. Happy Mother's Day!

Bill Farmer: Gave monthly utility report. Water restrictions are in place for April 15th - September 30th. Fire hydrant flushing should be completed by the week of May 16th.

Joseph Marte: Spoke about the monthly police report. Announced that the Junior Police Academy will return this summer from July 11th – July 15th. Officer of the month is Ptl. Rob Armstrong. There were 250 applications that applied for our Police Department. The committee will always support our officers. Thanked and recognized all our Veteran's and active servicemen. Happy Mother's Day and Happy Memorial Day!

Pat Pipi: Gave code enforcement report. There were 17 rental inspections, 39 letters of no interest, 93 zoning permits, 20 summons issued and 39 warning stickers.

<u>Mayor's Report:</u> National Night Out is on August 2nd at the High School. Starve Poverty's open house will be on May 21st on Rt. 72. All welcome! Did research on Comcast. Only option is streaming. Kurt Otto spoke about paving on Rt. 9. Paving will start the week of May 10th – May 20th. Will start in Manahawkin to Barnegat. Side streets will be done another time. Work is weather permitting. All paving will be done at night. Please be cautious when driving on Rt. 9 at night.

Kurt Stofko: 373 N. Main St. – Represents the Community Garden. They will not charge rent for residents. Still will help the community who can't have a garden. Setting up as a non-profit, 5013C.

Diane Grockenberger: 108 Redwood Dr. – Starve Poverty is doing a wonderful job. No water on fire side of building. Wants to know if they can use the building as a meeting place. The community is having something on May 21st, concerned about the parking. Can you put the police on 532 or put a light so people can get out? Pinewood Estate had a main water line break and they dug up by the office. They put it all back together over weekend so town won't see it. Mayor will follow up. Also suggested to contact the Attorney General Office or Consumer Affairs.

Phil Cecchia: 12 Windward Dr. - Support Ukraine. How soon before bid went out? Upset with added cost of new building.

Mr. & Mrs. Passiatore: 7 Liberty Court - On going issue since 2015 with resident running business out of home. The business has expanded. Parking buses on lawn, making noise at 5:30am. Went from 1 vehicle to 20 vehicles. State Police shut the road down. Don't understand why they are still operating a business out of their home. Sick of the situation. Trailer on property has not moved in 2 years. Upset that town is not doing anything! Attorney said there is a pending municipal court. Town committee cannot make comments.

Fred Rubenstein: 4 Hickory Circle – Touched base on the Elizabeth Edwards School. Asbestos abate is not a simple matter. Potential for danger. Keeping close tabs on the school. Support Ukraine! World is watching our county.

John Gennarelli: 102 Pine Oak Blvd. - Mentioned that they are having their last school meeting for the year. Asking what the process is with hopefully getting a TV channel and getting information out to the public about our school district. Is a Pheasant Run Trustee. Trying to stay in rules & regulations with Pheasant Run. Quality of life issues. Asking for help to keep quality of life. Barnegat is a great town!
