**RESOLUTION OF THE TOWNSHIP OF
BARNEGAT, COUNTY OF OCEAN, STATE OF
NEW JERSEY, GRANTING PRELIMINARY
SANITARY SEWER FACILITIES APPROVAL TO
BARNEGAT TERRACE LLC FOR THE PROJECT
KNOWN AS STONEHILL AT BARNEGAT II**

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has received a request from the developer Barnegat Terrace LLC (the “Developer”) for an application known as Barnegat at Stonehill II property known as Block 175, Lots 1 and 2, Block 176, Lot 1, Block 181, Lot 1, Block 182, Lot 1, Block 183, Lot 1, Block 184, Lots 1, 2 and 3 (the “Project”); and

WHEREAS, the Developer has provided submittals to the Township for review by the Township Engineer for granting of preliminary sanitary sewer facilities approval; and

WHEREAS, the Township Engineer has reviewed the submission and issued a review memorandum dated October 21, 2022, a copy of which is attached hereto and made a part hereof recommending granting the application for preliminary sanitary sewer facility approval subject to the terms set forth in the review memorandum; and

WHEREAS, the Township accepts the recommendations of its professional staff; and

NOW, THEREFORE, BE IT RESOLVED on this 6th day of December, 2022 by the Mayor and the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township hereby grants preliminary sanitary sewer facilities approval to Barnegat Terrace LLC for the Project known as Stonehill at Barnegat II subject to the
