**A RESOLUTION OF THE TOWNSHIP OF BARNEGAT,  
COUNTY OF OCEAN AND STATE OF NEW JERSEY  
DENYING PERFORMANCE BOND REDUCTION  
REQUEST OR BOND RELEASE FOR SANITARY SEWER  
SYSTEM FACILITIES FOR OCEAN ACRES PHASE 8**

**WHEREAS**, the Township Committee of the Township of Barnegat, State of New Jersey has received a request from the Developer Walters Development, Co. for release or further reduction of a Performance Guarantee (Bond #4-082-032) for Sanitary Sewer Facilities for a project known as Ocean Acres—Phase 8; and

**WHEREAS**, the Township’s consulting engineer CME Associates has inspected the Performance Guarantee and has provided a review memorandum dated November 26, 2022 recommending that no further bond reduction or release be approved at the present time; and

**WHEREAS**, a copy of the November 26, 2022 review memorandum from CME Associates is attached hereto and made a part hereof; and

**WHEREAS**, the Township accepts the recommendations of its professional staff.

**NOW THEREFORE BE IT RESOLVED** this 1st day of January 2023, by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, and State of New Jersey as follows:

1. The Township accepts the recommendation of its professional staff and denies any bond reduction or release for Performance Guarantee Bond #4-082-032 for sanitary sewer system facilities for Ocean Acres—Phase 8 pursuant to the November 26, 2022 review memorandum of the Township’s consulting engineer CME Associates.
