AUTHORIZING REDUCTION OF PERFORMANCE
GUARANTEE FOR WATER SYSTEM
IMPROVEMENTS FOR OCEAN ACRES PHASE 11**

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (the “Township”) has received a request from the Developer Walters Development Company for reduction of the Performance Guarantee Bond #PB00459500068 for water system improvements for Ocean Acres Phase 11; and

WHEREAS, the Township’s consulting engineers CME Associates has performed a site inspection of the water system improvements and has issued a review memorandum dated November 26, 2022, a copy of which is attached hereto and made a part hereof, recommending reduction of the Performance Bond #PB00459500068 in accordance with the provisions of the Municipal Land Use Law, N.J.S.A. 40:55D-1 et seq. in the amounts set forth below:
