Submitting Annual Backflow Preventer Permits

- 1. Complete the attached Permit Form in its entirety
- 2. Copy of Backflow Certification(s) that it has passed
- 3. Copy of Backflow Certifier's license.
- 4. Enclose a check for the amount of backflows you have. If you have 1 backflow. The cost of ONE backflow certification is \$100.00 PLUS a \$1.00 DCA fee. So the check should be \$101.00 If you have 2 it will be \$200.00 plus \$1.00 = \$201.00 and so on.

All Backflow Certifications DUE July 1st of EVERY YEAR

To whom it may concern,

This letter is to inform you that you have a testable backflow prevention device(s) (BFP) in your building.

(Backflow is the flow of liquids (water, antifreeze, stagnant fluids, etc.) into the potable (domestic) water system in reverse, causing contamination.)

Testable BFP devices require:

- a) a yearly test as per the Uniform Construction Code, adopted 9/8/09, section NJAC 5:23-2.23 (1)
- b) a certificate of compliance, which expires at the end of every calendar year

It is the responsibility of the owner of the structure to make sure that a yearly test is done on these devices, and a certificate of compliance is received.

This is accomplished by hiring a licensed and certified backflow prevention testing technician, to do a test of the device (s) to assure they are operating properly.

Failure to comply with this regulation can result in fines up to \$2000.00

This technician must apply to our office for a plumbing permit and have proof of their certification. The application must be filled out and submitted with two copies of the passed test result, along with a Total Fee of \$101.00 - \$100 dollar fee for every BFP in the building and then a \$1.00 DCA fee. Please be aware that BFP not passing the test must be repaired or replaced. A plumbing permit is required to replace a BFP.

(e.g.; you may have a backflow device(s) for your fire sprinkler system, one for your domestic water system and one for your lawn irrigation).

Remember, this must be done once a year for the life of the structure. By doing this, you protect the water system from contamination If you have questions, you may call me @ 609-698-0080 ext 153
