Mr. Bauer explained the Applicant is looking to put up a detached garage. The project is a 310 unit apartment complex consisting of 30 buildings. The outdoor garage area would be used as storage allowing the clearing up of an existing area that is being used for storage and potentially opening it up for another amenity. He explained the proposal is for a 24x14 Amish shed that will be located on a concrete pad and used to store maintenance equipment.

Committeeman Bille commented the only concern from Mr. Taylor, the Planning Board's planner was in relation to the color; but he noted the proposed color coordinates with what exists at the site. Mr. Worth corrected the record that the proposal is for 24x24 and 14.84 inches high. He clarified the proposed location noting this does not impact any parking and there will be no clearing of trees necessary. Ms. Perrulli confirmed for the Board this will be used strictly for storage, adding no electric is being proposed.
