## RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING SETTLEMENT AGREEMENT OF LITIGATION

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, (the "Township") instituted litigation captioned <a href="Barnegat Township v. Well Fargo Bank">Barnegat Township v. Well Fargo Bank</a>, N.A., et al. in the Superior Court of New Jersey, Law Division, Civil Part, Docket No. OCN-L-1211-22; and

WHEREAS, the litigation involved the illegal resale of an affordable housing unit for more than the affordable housing resale price; and

WHEREAS, the parties engaged a mediator to mediate and resolve the matter; and

WHEREAS, the matter has been resolved subject to approval by the Township Committee in that a number of defendants will contribute to a total settlement amount paid to the Township in the amount of \$205,475.30. The settlement amount is inclusive of reimbursement of the Township for all legal fees and costs; and

WHEREAS, as a result of the payment of the settlement monies, the Township will dismiss the litigation and release the affordable housing controls on the property known as 51 Lamp Post Drive, Barnegat, New Jersey also known as Block 114.36, Lot 32.01 on the Tax Map of the Township of Barnegat; and

WHEREAS, the Township accepts the recommendation of its professional staff and finds it necessary and appropriate to authorize the settlement; and
