Committee Reports; Farmer, Cirulli, Marte, Bille

Al Cirulli: Fire Report – There were 40 calls for the month of October. They accomplished Fire Prevention week for all schools.

Joseph Marti: Thanked the citizens of Barnegat for voting for him. Gave Police report. In October our officers answered 1532 calls for services, including 45 MVA. Our Crime Reduction Unit made 8 arrest. Read a letter from a resident, Carol Castellano. She fell and was unable to get up. She called 911. Officer Brett Taylor and another officer were kind and professional. Her garage door has not been working right. Officer Taylor was kind enough to fix her garage door as well as helping her. Barnegat Police Department is absolutely the greatest! They are well trained, responsive and superior! Thank you Barnegat Police! November 11th is Veteran's Day and thanked all of our Veteran's.

<u>Mayor's Report:</u> Congratulated Joe and Al on their win. Spoke about how men should not be playing in women's sports. Gave examples of women getting hurt. Men and women are equal but not the same! Encouraged parents to speak up. Let your voices be heard.
