# Committee Reports: Bille, Pipi, Townsend, Cirulli

**Al Bille:** Mentioned that you can use black bags for garbage. Property taxes are lower than Stafford! Recreation – Family night will be in June & July. Outdoor movies will be moved indoors at the recreation center. Had 25 applicants for Snowman contest. Winners will be announced March 11<sup>th</sup>. Pirates Day will be May 4<sup>th</sup>. Congratulated the Chief on his retirement. Congratulated new Chief.

**Pat Pipi:** Code Report – There were 20 rental inspections, 26 letters of no interest, 9 summons and 61 warning stickers issued. Congratulated Chief and the new Chief.

**Jake Townsend:** Gave water report for the month of February. Best Wishes to the Chief and Congratulated the new Chief.

**Al Cirulli:** Read letter from N. Brunswick's Mayor, Francis Womack to our fire department. For the month of February there was 26 calls and for January there was 51 calls. State requires tremendous amount of training for our volunteers. Barnegat First Aid is a tremendous back up for Quality Medical Squad. Quality had 205 calls. Congratulated the Chief on his retirement. Mentioned that the Chief was in his middle school workshop class.

Chris Dasti: Gave speech about Chief Germain

**Marty Lisella:** Gave speech about Keith. Developed a relationship with him through the years. Mentioned how he showed lots of loyalty and leadership. Wished Keith the best in his retirement and welcomed Jay in his new position.

<u>Mayor's Report:</u> Police Report – Released 2023 Annual Report. There was 19,910 calls for service, 594 MVA, 530 firearms application and 136 carry permits. Crime Reduction Unit - \$125,000 in contraband. Detectives assigned in 400 cases. Was quite a year! Gave speech about Chief Keith Germain. March 13<sup>th</sup> the legend will depart.

**Chris Hanlon:** Attorney for Pinewood Estates – Talked about rent control. Has been involved since 1978. Multimillion dollar property. Only income is from rentals. CPI increases 3 1/2% on rent. We did have a responsible response to the residents. Asking to not to adopt this Ordinance. Lowest rents in the State. Have to maintain this property. Possible partner with the town.

**Al Cirulli:** Suggested for Mr. Hanlon to address the resident's concerns. We have to stand by our people. Can accomplish if you all sit down and work things out.

**Dave:** 186 Chestnut Dr. - Thanked committee for listening. Reinstating is our protection for us. RHP wants to double our lot rent. Told us there will be a loyalty discount. You have a choice, pay us or leave. The committee is the buffer. We had asked last year to reinstate. We respect the RHP rights to a profit. It's a multimillion dollar corporation. Roads are not paved, doesn't matter. Just want an affordable place to live. We don't have protection from greedy landlords!

**Lorraine Ferraro:** 121 Cypress Lane – Communication is lacking. They are taking our privileges away from our clubhouse. They are a corporation. Nothing wrong with making a profit but we need protection. Asking for help! Thank you.

**John Murrin:** 38 Pierhead Dr. - Mentioned that the professionalism of our Police Department is amazing! The accessibility of Police is great! Rent Leveling – Understands what Mr. Hanlon said. Just not for Pinewood, Brighton will benefit as well. Mr. Hanlon can negotiate before board. Hope you approve Ordinance.

**John Gennarelli:** 102 Pine Oak Blvd. – Said that channel 22 is completely black. Any update on building. Kurt answered saying estimate late May. Move in possibly July. Depends on Department of Corrections. Need green light on Police Department side. Questioned on water tower. Kurt said application has been made. Can take several month.

**Ray Lescheck:** 116 Redwood Dr. – Understands everything Mr. Hanlon said. Would like the objectives of RHP. No information to the residents. Asked for accountability on money spent. Need more information. Hope for the rent leveling will go through.

**Tom Randazzo:** 4 Spring Lake Ct. - Spoke about criminals go where the money is. Is the town or Police doing anything?

**Frank Troia:** 117 Redwood Dr. - Questioned what the market value is on our homes? We make our properties nice and RHP gets the benefits of market value.

**Ray Lescheck:** 116 Redwood Dr. - We need Ordinance in place in case we need to go to court. We need protection for the people.
