RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING THE COLLECTIVE BARGAINING AGREEMENT WITH AFSCME DISTRICT COUNCIL 63/LOCAL 3304J/DEPARTMENT HEAD EMPLOYEES

WHEREAS, the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township") accepted and authorized the execution of a Collective Bargaining Agreement with AFSCME District Council 63/Local 3304J/Department Head Employees on February 6, 2024 under Resolution 2024-98; and

WHEREAS, the Township finds it necessary and appropriate to authorize execution of an Amendment to the AFSCME District Council 63/Local 3304J/Department Head Employees Collective Bargaining Agreement ratified on February 6, 2024; and

WHEREAS, the current AFSCME District Council 63/Local 3304J/Department Head Employees Collective Bargaining Agreement is on file at the Office of the Township Clerk and can be viewed during normal business hours.

NOW, THEREFORE, BE IT RESOLVED on this 6th day of August, 2024 by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township hereby authorizes the amendments codified hereto and attached herewith.

3. The Township hereby authorizes the Mayor, Township Administrator, Township Clerk and AFSCME Representatives to execute any and all documents to implement the intent of this resolution.

**AFSCME DISTRICT COUNCIL 63/LOCAL 3304J DEPARTMENT HEAD
AGREEMENT AMENDMENT**

WHEREAS, the Barnegat Township Committee has previously adopted Resolution 2024-98 on February 6, 2024 accepting and authorizing the execution of a Collective Bargaining Agreement with AFSCME District Council 63/Local 3304J/Department Head Employees; and

WHEREAS, the Township finds it necessary and appropriate to authorize an alteration/amendment to the AFSCME District Council 63/Local 3304J/Department Head Employees Collective Bargaining Agreement as follows:

1) Correcting Article 26, Section F, to reflect the removal of the stipend maximum of \$15,000.00; and

2) The corrective language for Article 26, Section F, shall now and hereinafter read as follows: “In the event of a Shared Service Agreement and at the discretion of the Township Administrator, a stipend shall be paid to the Department Head based upon work performed. This shall be paid in the base salary as an additional amount as long as those duties are performed by the Department Head. Shared Service would only occur if the Township is receiving compensation for the shared service and the affected Employee would split the compensation that the Township receives”; and

WHEREAS, all other terms of the AFSCME District Council 63/Local 3304J/Department Head Employees Collective Bargaining Agreement dated January 1, 2024 through December 31, 2027 shall remain in full force and effect.
