**RESOLUTION OF THE TOWNSHIP OF BARNEGAT,  
COUNTY OF OCEAN, STATE OF NEW JERSEY,  
AUTHORIZING A MEMORANDUM OF UNDERSTANDING  
BETWEEN THE TOWNSHIP OF BARNEGAT AND THE  
OCEAN COUNTY SHERRIFF'S DEPARTMENT FOR THE  
USE OF THE LAW ENFORCEMENT FIREARMS  
TRAINING FACILITY FOR THE BARNEGAT POLICE  
DEPARTMENT PERSONELL LOCATED AT  
1535 ROUTE 539, LITTLE EGG HARBOR, NJ**

**WHEREAS**, the County of Ocean through its Department of Law and Public Safety Sheriff's Department operates a Law Enforcement Training Facility, located at 1535 Route 539, Little Egg Harbor, NJ 08087 which is utilized for firearms training and qualifications by various law enforcement agencies within Ocean County; and

**WHEREAS**, the facility operates under a fee schedule, however, the Ocean County Sheriff's Department is offering this service free of charge to all Ocean County Municipal Police Departments; and

**WHEREAS**, the Barnegat Police Department is currently in need of a training and qualification facility; and

**NOW THEREFORE BE IT RESOLVED** on this 6<sup>th</sup> day of August, 2024, by the Mayor and Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey as follows:

1. The Township hereby authorizes the execution of the Memorandum of Understanding between the Ocean County Board of Commissioners and the Township which will be held on file at the office of the Township Clerk and can be viewed during normal business hours.

2. The Township authorizes the Mayor, Township Clerk, Township Administrator, Chief of Police, and any other appropriate official to execute the documents necessary to implement the intent of this resolution.
